BACKGROUND: Summary (continued)

The Department of Public Health, Riverside County Healthcare System, Department of Mental Health, Riverside County Regional Medical Center, Department of Social Services, and the Probation Department routinely use laboratory services not performed by the County's in-house testing laboratories due to the complexity of the required tests involved. The service agreement covers services such as stat fees, pick-up and delivery of samples, consultation, esoteric testing, field support, drug testing and phlebotomy services, and provides for tests performed per Medi-Cal Managed Care capitation rates.

In September 2013, County Purchasing issued a bid for these lab services. With Huron coming on board, Huron reviewed the bid results and the requirements countywide. After a review of tests and services being conducted by RCRMC, Huron indicated that some of the testing and services that are currently being provided by the contractor could be done by County Departments. Therefore, County Purchasing canceled the RFQ and has issued RFP PUARC-1337 on December 18, 2013 with the updated scope of work. The RFP will close in February 2014. The County will have a contract in place on or before June 30, 2014.

Price Reasonableness

The Contractor has held expired contract prices.

Impact on Citizens and Businesses

Services provide care and treatment for citizens throughout the County.
