

Cal Learn is a mandatory program for Cal-Works recipients who are 18 years of age and younger and voluntary for eligible recipients who are 19 years old. All eligible Cal Learn Program participants are pregnant or custodial parents and have not obtained a high school diploma or equivalent.

BACKGROUND:

Summary (continued)

The program encourages these parents to stay in school by offering monetary incentives, providing supportive services, and by imposing sanctions. Since the inception of the Cal Learn Program, County of Riverside Department of Public Social Services (DPSS) has reinstated an interagency agreement with the Department of Public Health to provide case management services as outlined in the Memorandum of Understanding for its Cal Learn clients. This County mandated program provides the following for participants:

- Individual, comprehensive case management services;
- · Assessment of health, education, nutritional, and psycho-social needs and appropriate referral;
- Emotional support for participant and family; and
- Emphasis on parenting education, child abuse prevention, family planning, high school completion, and maximizing vocational pursuits.

Impact on Citizens and Businesses

The Cal Learn Program is to enhance the health, educational achievement, economic, personal, and societal integration and independence of pregnant and parenting adolescents and reduce welfare dependency by encouraging and assisting pregnant or parenting adolescents to stay in (or return to) high school and graduate.

Additional Fiscal Information

With the estimated number of Cal Learn clients consistently being higher than originally projected, Riverside County Department of Public Social Services approved additional funding for three (3) FTEs and project costs, as listed below, and in the amount of \$279,959. The Cal Learn Program position request to Amend Ordinance 440 and add the following positions. Pursuant to Board Policy A-30, these positions will be eliminated once funding is exhausted.
