BACKGROUND:

Summary (continued)

The developed rates support a \$15.3 million operating budget for FY14/15, a reduction of approximately \$476,000 from the FY 13/14 developed rate package, and an overall 3% cost reduction to county departments. The decrease is a result of refining operating costs as the system is now up and operational as of January 2014.

PSEC is meeting with various public agencies to encourage their adoption and utilization of the new system to maximize regional integration and interoperability of public safety agencies. PSEC continues to enhance operational effectiveness to support the 75 sites and 4,250 system users.

Impact on Residents and Businesses

The PSEC public-safety radio system provides Riverside County first responders with enhanced levels of interoperability with other police and fire agencies through the County, including surrounding counties and other areas of Southern California.

SUPPLEMENTAL:

Additional Fiscal Information

Anticipated charges to county departments will be less than the FY13/14 projections as a result of the delayed PSEC System implementation. Interim rates were established effective July 1, 2013, that included the operating expenses required to support the expanded PSEC infrastructure and expenses to support the EDAC legacy system through December 2013.
