**SUBJECT:** Approval of the building automation system (The Apogee Energy Management System) maintenance agreement with Siemens Industry, Inc. District 5; [\$31,268]; RCRMC Enterprise Fund

#### **RECOMMENDED MOTION:** That the Board of Supervisors:

- 1. Approve and authorize the Purchasing Agent to execute the agreement for maintenance of the existing Apogee Energy Management System with Siemens Industry, Inc., without securing competitive bids, in accordance with Ordinance 459.4 for a period of performance one year, effective December 1, 2013, for an amount not to exceed \$31,268 annually; and,
- 2. Authorize the Purchasing Agent, in accordance with Ordinance 459.4, to sign amendments that do not change the substantive terms of the agreement, and to allow the Purchasing Agent to increase the compensation amount not more than ten percent of the annual amount over the twelve month period.

#### **BACKGROUND:**

#### **Summary**

Riverside County Regional Medical Center (RCRMC) is a full service medical center providing medical services for both inpatients and outpatients. The Apogee Energy Management System is currently in use to provide automated system control of heating, ventilation and air conditioning throughout the Medical Center. The Apogee Energy System is a proprietary product of Siemens Industry, Inc.

#### Impact on Residents and Businesses

This service impacts the patients of RCRMC many of whom reside in Riverside County.

#### **Contract History and Price Reasonableness**

County entered into a five year agreement with Siemens Industry Inc., to provide maintenance for the Apogee Energy Management System utilized by the Medical Center in 2008. Siemens is the only company providing software upgrades and programming necessary to maintain the Apogee Energy Management System. The County will benefit from the continuance of the agreement with Siemens because failure to do so will require the purchase and installation of a whole new system at significant cost to the County. Siemens has provided this service to RCRMC for several years and has not asked for a price increase in the previous five years.
