WHEREAS, the Riverside County Regional Park and Open-Space District has the authority to construct, operate, and maintain the Laker Skinner Recreation Area Boat Launch Facility; and

WHEREAS, the Riverside County Regional Park and Open-Space District is requesting \$546,780 in grant funds from the Division of Boating and Waterways; and

WHEREAS, the Riverside County Regional Park and Open-Space District desires to enhance, repair, or rebuild and protect the Lake Skinner Recreation Area Boat Launch Facility to meet the needs of watercraft users and provide other public amenities to those utilizing the facility, therefore;

NOW, THEREFORE, BE IT RESOLVED by the Riverside County Parks District Board of Directors that, pursuant and subject to all of the terms and provisions of the Harbor and Watercraft Revolving Fund program, application be made to the State of California, Department of Parks and Recreation, Division of Boating and Waterways for funding; and

BE IT FURTHER RESOLVED that the General Manager of said Riverside County Regional Park and Open-Space District is hereby authorized and directed to cause the necessary data to be prepared and application to be signed and filed with the Division of Boating and Waterways.
