BACKGROUND:

Summary

The Local Agency Public Construction Act (Public Contract Code Section 20100 et seq.) and Uniform Public Construction Cost Accounting Act (Public Contract Code Section 22000 et seq.) requires officials to invite bids for construction projects and award contracts to the lowest responsible bidder. The Local Agency Public Construction Act (Public Contract Code Section 20101 et seq.) allows officials to prequalify contractors for public works projects.

On January 7, 2014, the Board of Supervisors approved and authorized the Economic Development Agency (EDA) to issue the Pre-Qualification Package for General Contractors for the purpose of compiling a list of Pre-Qualified Entities. Separately on January 7, 2014, the Board approved and authorized EDA to issue the Pre-Qualification Package for Electronic Security Contractors for the purpose of compiling a list of Pre-Qualified Entities.

An evaluation committee was formed that included representatives from EDA, the Sheriff's Department, Hellmuth, Obata and Kassabaum, Inc. (HOK) and Vanir Construction Management to review each contractor's qualifications. After reviewing the submitted pre-qualification responses, the evaluation committee determined the contractors listed in Exhibit A are qualified to bid the project in their respective specialties.

The construction documents are being prepared and the project team is making preparations for the bidding phase. This process of pre-qualifying a pool of general contractors will help ensure the bids received will be from entities that have experience on large complex facilities such as a detention center.

Impact on Residents and Businesses

Approval of the pre-qualification of General Building Contractors and Electronic Security Contractors will position the county to successfully and expeditiously construct the ECDC project which will enhance public safety and provide job creation, thus providing positive impacts to area residents and businesses of Indio.

Minor impacts associated with normal construction may occur which include temporary lane closures or other traffic modifications of city streets leading to and from the project and, normal noise and air quality associated with the demolition and the construction of the expansion.
