BACKGROUND:

Summary

The County Transportation Improvement Program provides for the construction of the Columbia Street Sidewalk Project, Acacia Avenue to Tava Lane. In addition to the new sidewalk improvements, any damaged curb and gutter and non-compliant Americans with Disabilities Act (ADA) driveways and access ramps will be removed and replaced.

Columbia Street is one of the major pedestrian routes for Ramona Elementary School and St. John's Lutheran School. The parkway on Columbia Street currently contains obstructions to pedestrian use, such as fences, trees, and random landscape and hardscape. This project proposes to construct approximately 1,100 linear feet of new sidewalk and 11 new access ramps, providing a safer pedestrian path for students and their families.

Construction will take place during school recess to minimize disruption to parents and students of the schools. Resurfacing of Columbia Street between Florida Avenue and Stetson Avenue will follow as a separate contract later this year.

The submitted plans and specifications have been approved as to form by County Counsel, and environmental clearance is complete.

Impact on Residents and Businesses

The proposed improvements will improve pedestrian safety and provide an ADA compliant path.

Additional Fiscal Information

The construction contract is estimated to cost approximately \$230,000. Construction will be funded with Gas Tax and SB-821 Local Transportation Funds, for which the County successfully competed. There are no General Funds used in this project.




