BACKGROUND: (Continued)

Pursuant to Riverside County Ordinance No. 573 and Government Code 25215 et seq., the proposed fiscal year 2014-2015 charges are attached as Exhibit A. As provided in County Ordinance 573, the rate of charge for each County Service Area is calculated by dividing the net cost of the service of the total number of parcels receiving the service. In addition, some CSA special assessments were established by an engineer's report that includes an annual adjustment by the greater of two percent or the cumulative percentage increase in the Consumer Price Index for all Urban Consumers (CPI-U) as it stands on February of 2014, and were increased accordingly.

Impact on Residents and Businesses


County Service Areas allow communities in unincorporated areas to pay for and receive specific services from the county. Residents receive the type of services and improvements not available in other areas of the county.
