There are currently two vacancies on the Board of Directors of the Cabazon Water District. Water Code 30504, provides that if the vacancies of the Board of Directors are not filled by the Water District's Board of Directors by appointment, or if the Board of Directors does not call an election within 60 days of the vacancies, than the County Board of Supervisors may appoint individuals to fill the vacancies within 90 days of the date of vacancies.

It is my recommendation that: Janet Mejia be appointed to fill an unexpired term ending 12/1/15 and that Martin Sanderson be appointed to fill an unexpired term ending 12/1/15.
