BACKGROUND:

Summary

Landscaping and Lighting Maintenance District No. 89-1-Consolidated (District) maintains and services 138 locations throughout Riverside County. The District contains 63 separate assessment zones and 57 street lighting assessment zones as described in Attachment A.

Consistent with the Board's direction regarding compliance with Article XIIID of the California Constitution and the Landscaping and Lighting Act of 1972, the attached resolutions have been prepared and a public hearing scheduled for 9:30 a.m. on July 1, 2014, to receive testimony for and against the proposed assessments.

Impact on Residents and Businesses

Only the property owners within the boundaries of each Zone within L&LMD No. 89-1-C are impacted by the assessments collected for the maintenance of the improvements within these zones, as described in Attachment A and the Engineer's Report.

Depending on the time the Zones were annexed into L&LMD No. 89-1-C, and the type of improvements, the mailed assessment ballot proposition approved by the property owners provides for these assessments and that either no inflation factor was established (Zones 1 and 3), a two percent (2%) inflation factor was established, or the annual assessment may be increased each year by the greater of two percent (2%) or the cumulative percentage increase, if any, in the Consumer Price Index (CPI-U), or the Consumer Price Index for electricity (CPI-U "for electricity"), for the Los Angeles-Riverside-Orange County California Standard Metropolitan Statistical Area (the "Index") as the Index stands as of March of each calendar year.

SUPPLEMENTAL:

Additional Fiscal Information

The annual budget for fiscal year 2014-15 totals \$1,467,609. For Fiscal Year 2014-15 the inflation factor, when appropriate, will be two percent (2%).

The inflation factor affects the maximum assessment, which is the maximum allowable assessment to be placed on a parcel, acre, or equivalent dwelling unit (EDU) within L&LMD No. 89-1-C. Zones may be assessed at the maximum assessment if needed, however some zones are assessed less depending on overall annual maintenance costs and existing reserves, if any.

Zone 1

For fiscal year 2014-15, there is no proposed increase in the maximum assessment for Zone 1. The proposed maximum assessment for fiscal year 2014-15 for Zone 1 of the District is \$178.52 per acre. The actual rate property owners pay is based on the parcel size and there are 450 parcels.

Zone 1 was established 17 years ago with an assessment of \$178.52 per acre per year and did not establish an inflation factor. The proposed budget for fiscal year 2014-15 is \$14,777.89.

Zone 3

For fiscal year 2014-15, there is no proposed increase in the maximum assessment for Zone 3. The proposed maximum assessment for fiscal year 2014-15 for Zone 3 of the District is \$77.68 per parcel and there are 314 parcels.

Zone 3 was established 16 years ago with an assessment of \$77.68 per parcel per year and did not establish an inflation factor. The proposed budget for fiscal year 2014-15 is \$24,391.52.

Zone 8

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 8 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 8 of the District is \$46.34 per EDU (Equivalent Dwelling Unit) and there are 2,462 parcels.

Additionally \$22,000 in Ad Valorem monies is provided to Zone 8 annually.

Zone 8 was established 14 years ago with an assessment of \$41.16 per EDU per year. The proposed budget for fiscal year 2014-15 is \$128,468.38.

Zone 10

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 10 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 10 of the District is \$380.66 per acre. The actual rate property owners pay is based on the parcel size and there are 28 parcels.

Zone 10 was established 13 years ago with an assessment of \$321.32 per acre per year. The proposed budget for fiscal year 2014-15 is \$29,322.24.

Zone 11

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 11 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 11 of the District is \$128.00 per parcel and there are 243 parcels.

Zone 11 was established 10 years ago with an assessment of \$109.00 per parcel per year. The proposed budget for fiscal year 2014-15 is \$31,104.00.

Zone 15

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 15 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 15 of the District is \$392.88 per parcel and there are 121 parcels.

Zone 15 was established 11 years ago with an assessment of \$345.50 per parcel per year. The proposed budget for fiscal year 2014-15 is \$47,538.48.

Zone 19

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 19 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 19 of the District is \$200.60 per parcel and there are 185 parcels.

Zone 19 was established 12 years ago with an assessment of \$152.02 per parcel per year. The proposed budget for fiscal year 2014-15 is \$37,111.00.

Zone 24

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 24 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 24 of the District is \$126.34 per parcel and there are 314 parcels.

Zone 24 was established 11 years ago with an assessment of \$100.00 per parcel per year. The proposed budget for fiscal year 2014-15 is \$39,670.76.

Zone 26

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 26 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 26 of the District is \$138.58 per parcel and there are 417 parcels.

Zone 26 was established 11 years ago with an assessment of \$111.46 per parcel per year. The proposed budget for fiscal year 2014-15 is \$57,787.86.

Zone 28

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 28 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 28 of the District is \$109.14 per parcel and there are 98 parcels.

Zone 28 was established 11 years ago with an assessment of \$87.76 per parcel per year. The proposed budget for fiscal year 2014-15 is \$10,695.72.

Zone 29

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 29 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 29 of the District is \$87.02 per parcel and there are 130 parcels.

Zone 29 was established 11 years ago with an assessment of \$70.00 per parcel per year. The proposed budget for fiscal year 2014-15 is \$11,312.60.

Zone 31

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 31 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 31 of the District is \$293.64 per parcel and there are 60 parcels.

Zone 31 was established 11 years ago with an assessment of \$250.00 per parcel per year. The proposed budget for fiscal year 2014-15 is \$17,618.40.

Zone 36

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 36 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 36 of the District is \$114.80 per parcel and there are 106 parcels.

Zone 36 was established 10 years ago with an assessment of \$92.30 per parcel per year. The proposed budget for fiscal year 2014-15 is \$12,168.80.

Zone 39

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 39 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 39 of the District is \$53.42 per parcel and there are 128 parcels.

Zone 39 was established 10 years ago with an assessment of \$47.00 per parcel per year. The proposed budget for fiscal year 2014-15 is \$6,837.76.

Zone 43

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 43 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 43 of the District is \$156.62 per parcel and there are 516 parcels.

Zone 43 was established 9 years ago with an assessment of \$140.50 per parcel per year. The proposed budget for fiscal year 2014-15 is \$80,815.92.

Zone 44

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 44 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 44 of the District is \$59.12 per parcel and there are 1,173 parcels.

Zone 44 was established 9 years ago with an assessment of \$55.72 per parcel per year. The proposed budget for fiscal year 2014-15 is \$69,347.76.

Zone 45

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 45 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 45 of the District is \$252.04 per parcel and there are 209 parcels.

Zone 45 was established 9 years ago with an assessment of \$206.72 per parcel per year. The proposed budget for fiscal year 2014-15 is \$52,676.36.

Zone 53

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 53 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 53 of the District is \$434.36 per parcel and there are 32 parcels.

Zone 53 was established 9 years ago with an assessment of \$356.24 per parcel per year. The proposed budget for fiscal year 2014-15 is \$13,899.52.

Zone 55

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 55 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 55 of the District is \$67.64 per parcel and there are 86 parcels.

Zone 55 was established 9 years ago with an assessment of \$65.12 per parcel per year. The proposed budget for fiscal year 2014-15 is \$5,825.64.

Zone 57

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 57 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 57 of the District is \$281.14 per parcel and there are 54 parcels.

Zone 57 was established 8 years ago with an assessment of \$230.56 per parcel per year. The proposed budget for fiscal year 2014-15 is \$15,181.56.

Zone 58

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 58 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 58 of the District is \$729.80 per parcel and there are 9 parcels.

Zone 58 was established 8 years ago with an assessment of \$641.78 per parcel per year. The proposed budget for fiscal year 2014-15 is \$6,568.20.

Zone 66

For fiscal year 2014-15, there is a proposed two percent (2%) inflationary increase in the maximum assessment for Zone 66 and is consistent with ballot proposition approved by the qualified electors when establishing said zone. The proposed maximum assessment for fiscal year 2014-15 for Zone 66 of the District is \$229.44 per parcel and there are 31 parcels.

Zone 66 was established 8 years ago with an assessment of \$216.22 per parcel per year. The proposed budget for fiscal year 2014-15 is \$7,112.64.

Zone 68
