**BACKGROUND:** Community Improvement Designation Funds, being held in an EDA fund for 1st District programs designed to assist Youth & Seniors, will be allocated to nine (9) 2014 High School Graduates, who served on the First District Youth Advisory Council, and are recipients of a First District Scholarship.

1. This scholarship award is designed to reward First District Youth Advisory Council Members (YAC) hard work, assist in their education and improve our community.
  - a. All 12th grade YAC members were able to apply for this scholarship.
2. Eligibility considerations are as follows:
  - a. Graduating seniors, attending community colleges, public colleges or universities, private universities, or eligible trade schools (proof of acceptance required)
  - b. Total number of hours that were contributed to the council?
  - c. How many years served as a member on the YAC? (up to \$250 per year served)
  - d. Has the YAC member demonstrated any growth?
  - e. What sorts of ideas or projects have been contributed to on the council?
  - f. Provision of Official Transcript
  - g. Two letters of reference (only school personnel will be considered, i.e. academic counselor, teacher or club coordinator)
