BACKGROUND:

Summary

On May 20, 2014, the Board of Supervisors adopted Resolution No. 2014-068, declaring the real property identified as APN 215-202-004 (the Property) to be of no necessity to the County, inviting bids to acquire the Property. Sealed bids will be opened by the Clerk of the Board, and the public will be invited to oral bids in accordance with the Resolution.

This property is located at 4154 12th Street, Riverside, County of Riverside, State of California. This is a residential type dwelling situated on approximately 10,454 square feet, located in the Almond Street District. The dwelling is approximately 1,559 square feet, consisting of 3 bedrooms, 2 baths, which was built in 1936. An independent appraisal conducted by the Real Estate Division found the fair market value to be \$260,000 for this property.

The sale proceeds will enable the County to better provide needed services to the community. Further economic impacts can be identified once a specific buyer is identified at the Public Hearing.


