#### **BACKGROUND:**

#### Summary (continued)

In compliance with the California Environmental Quality Act (CEQA) for the Lakeland Village Master Drainage Plan, Consultant began work on a first tier Environmental Impact Report (EIR). Due to delays associated with the development of the Lakeland Village Master Drainage Plan (MDP), Consultant requires additional time to complete the EIR.

County Counsel has approved the amendment as to form and Consultant has executed the amendment.

#### Impact on Residents and Businesses

Costs incurred under this amendment will be funded by ad-valorem property tax revenue and entail no new fees, taxes or bonded indebtedness.

#### SUPPLEMENTAL:

#### **Additional Fiscal Information**

Sufficient funds are included in District's budget for FY 2014-2015 and will be included in the proposed budget for FY 2015-2016, as necessary. The total amount of the contract shall not exceed two hundred thousand four hundred eleven dollars (\$200,411).

#### **Contract History and Price Reasonableness**

On October 5, 2010 (Agenda No. 11.4) the Board of Supervisors approved the Consulting Services Agreement between the District and Consultant, which set forth the terms and conditions by which Consultant would provide environmental consulting services for the preparation of a first tier EIR for the Lakeland Village MDP in compliance with CEQA.

On May 15, 2012 (Agenda No. 11.3) the Board of Supervisors approved Amendment No. 1 to increase the contract amount by thirty-eight thousand nine hundred sixty dollars (\$38,960) for additional scope of services, for a total contract amount not to exceed two hundred thousand four hundred eleven dollars (\$200,411).

#### AMENDMENT NO. 2

#### TO

#### CONSULTING SERVICES AGREEMENT ENVIRONMENTAL SERVICES LAKELAND VILLAGE MASTER DRAINAGE PLAN

The RIVERSIDE COUNTY FLOOD CONTROL AND WATER CONSERVATION DISTRICT, hereinafter called "DISTRICT", and DUDEK, a California corporation, hereinafter called "CONSULTANT", previously entered into that certain Agreement on October 5, 2010, for the project described as the Environmental Impact Report (EIR) for the Lakeland Village Master Drainage Plan (MDP), hereinafter called "AGREEMENT"; and

On May 15, 2012 DISTRICT and CONSULTANT entered into Amendment No. 1 to expand the scope of services and increase the total amount of compensation paid under said AGREEMENT from one hundred sixty-one thousand four hundred fifty-one dollars (\$161,451) to two hundred thousand four hundred eleven dollars (\$200,411); and

On May 30, 2013 DISTRICT'S General Manager-Chief Engineer authorized an extension of time for performance to June 30, 2014 pursuant to Section 3 of AGREEMENT; and

DISTRICT and CONSULTANT desire to amend the AGREEMENT and further extend the time for performance to June 30, 2015 with an option for one (1) additional one (1) year term through June 30, 2016.

NOW, therefore, the parties hereto mutually agree to amend AGREEMENT as follows, effective July 1, 2014:

#### 1. Provision 3 is amended to read:

#### 3. TIME FOR PERFORMANCE

"The term of this AGREEMENT shall become effective on the date the AGREEMENT is executed by DISTRICT'S Board of Supervisors, and shall remain

in effect through June 30, 2015. Prior to the termination date of this AGREEMENT, by mutual agreement of DISTRICT and CONSULTANT, this AGREEMENT may be renewed for an additional one-year term through June 30, 2016."

Except to the extent specifically added to, modified or amended hereunder, all of the terms, covenants and conditions of said AGREEMENT dated October 5, 2010 shall remain in full force and effect between the parties hereto.
