**BACKGROUND: Summary**

The U.S. Department of Housing and Urban Development (HUD) requires that all substantial amendments to the County's Five-Year Consolidated Plan and the One-Year Action Plan are subject to the Citizen Participation Plan and are approved by the Board of Supervisors and HUD. In accordance with the County of Riverside Citizen Participation Plan for the 2009-2014 Five Year Consolidated Plan, all new activities added to the 2013-2014 One-Year Action Plan, as well as any significant increases in funding to an existing project, are considered to be substantial amendments.

The projects, as described in Attachments A and B have been determined by staff to be eligible activities that meet a National Objective of the Community Development Block Grant program. Staff recommends approval of the new projects as substantial amendments.

Pursuant to 24 CFR 91.105 and the Citizen Participation Plan, the Economic Development Agency published the required public notices notifying the public of the comment period for the proposed substantial amendments to the 2013-2014 One-Year Action Plan, of the 2009-2014 Five-Year Consolidated Plan. No public comments have been received.

**Impact on Residents and Businesses**

CDBG funds will be used by the County to pay for ADA accessibility upgrades to the Event Pavilion area of the County Fairgrounds in Indio. The improvements will improve access for disabled persons attending events at the Fairgrounds.

The Torre-Martinez Desert Cahuilla Indians will use CDBG funds to pay for emergency upgrades to their Martinez Road community's fire suppression system. The TMDCI community provides housing and essential services to residents in an impoverished area of the County.
