SUBJECT: Transfer of Unclaimed Property Tax Overpayments to the County General Fund.
 (\$0). Districts ALL.

RECOMMENDED MOTION: That the Board of Supervisors:

1. Authorize the transfer of \$974,724.13 of unclaimed property tax overpayments to the County General Fund pursuant to the requirements of Section 5102 of the Revenue and Taxation (R&T) Code.
2. Transfer a total of \$4,332.74 in unclaimed property tax overpayments to the Treasurer-Tax Collector budget for reimbursement of cost incurred in the process.

BACKGROUND:

Summary

These overpayments are a result of R&T code 5097.2 (c) which states that "the amount paid exceeds the amount due on the property as the results of corrections to the roll or cancellations after those taxes were paid".

BACKGROUND:

Summary (continued)

In addition to the minimum requirements required by law, the Treasurer-Tax Collector has voluntarily adopted a policy which allows the claimant an additional 90 days to file a claim. As part of the policy, the following actions were taken to locate the rightful party of the unclaimed property tax overpayments which was above and beyond what we were required to do by law.

- Advertised in the newspapers for two consecutive weeks (Desert Sun, Palo Verde Valley Times & the Press Enterprise) referring potential claimants to the TTC's website*.
- Placed links on County's main website, the Property Tax Portal as well as the TTC's website* on May 1, 2014 through August 1, 2014 and requested links to be placed on each of the BOS websites.
- Contacted by phone each of the governmental entities that are on the unclaimed roll change refund list and directing them to the TTC's website*.
- Used Accurint (people finder) to call each claimant to direct them to our website in addition to sending out a letter referring them to the TTC's website*.

*The TTC's website included a detailed listing of all unclaimed property tax overpayments that have met the requirements of R&T code Section 5102.

We started out with 2,214 unclaimed property tax overpayments and 7 denied claims from last year totaling \$2,353,676.87. During the additional 90 day filing period we received 692 claims totaling \$1,378,952.74. We are requesting to transfer 1529 unclaimed property tax overpayments totaling \$974,724.13 to the general fund.

Impact on Citizens and Businesses

Claimants had an additional 90 days to file a claim per a policy voluntarily adopted by the Treasurer-Tax Collector.
