#### **BACKGROUND:**

## **Summary (continued)**

The UASI CERT Training Trailer is a logistical support trailer to an approved Community Emergency Response Team Training (CERT) Program. The (CERT) Program educates people about disaster preparedness for hazards that may impact their area and trains them in basic disaster response skills, such as fire safety, light search and rescue, team organization, and disaster medical operations. Using the training learned in the classroom and during exercises, CERT members can assist others in their neighborhood or workplace following an event when professional responders are not immediately available to help. CERT members also are encouraged to support emergency response agencies by taking a more active role in emergency preparedness projects in their community.

The CERT Training Trailer is self-contained to deliver on-site CERT 20-hour Basic Courses, CERT Advanced and CERT Refresher trainings. The Equipment contained within and listed in Attachment A is specifically intended to be deployed and used by State or Operational Area approved CERT Training Programs and Instructors. The UASI CERT Training Trailer has been acquired and equipped using U.S. Department of Homeland Security Urban Areas Security Initiative (UASI) Grant funds as administered through the City of Riverside. UASI CERT Training Trailers are housed and maintained by a host agency though are made available to local and regional CERT Training Programs as available and appropriate. The county, as the host agency, may provide the trailers to other Riverside County jurisdictions upon request. The two trailers will be strategically located in the east and west end of the County for use in our operational area.

The Riverside County Fire Department Office of Emergency Services (OES) will utilize these trailers for CERT training programs within the County of Riverside. We have approximately fifty (50) countywide CERT trainings and seven (7) refresher classes per year. These two CERT Trailers will allow OES to increase the number of trainings offered per year.

#### Impact on Citizens and Businesses

The two (2) CERT Trailers will increase the number of CERT trainings offered by the Fire Department Office of Emergency Services for the citizens of Riverside County. People who go through CERT training have a better understanding of the potential threats to their home, workplace and community and can take the right steps to lessen the effects of these hazards on themselves, their homes or workplace.

#### Additional Fiscal Information

The replacement costs of the Attachment "A" inventory in the trailer along with the maintenance and repair of the CERT Trailers will be the responsibility of the Fire Department. The costs are included in the FY 14/15 budget.

#### **Contract History and Price Reasonableness**

The City of Riverside UASI has previously provided the Fire Department grant funding for training. On July 15, 2014 Agenda #3-30, the Board of Supervisors accepted the 2012 UASI Grant with the City of Riverside. The 2012 UASI Grant provided funding for an OES Regional Training Project.
