BACKGROUND: Summary

On June 18, 2014, the Riverside County Sheriff Department approved a project with the Economic Development Agency (EDA) for the installation of perimeter fencing which includes automatic gates at designated locations, to raise the level of security and control of vehicular and pedestrian access.

On November 5, 2013, the Board of Supervisors approved a pre-qualified list of architectural and engineering firms to be retained on an as-needed basis. EDA has selected STK Architecture, Inc., (STK) from the pre-qualified list to provide architectural and engineering design services for the Southwest Justice Center Perimeter Fence project. STK has completed the plans and specifications for the project which includes the installation of fencing, gates, block wall and additional parking.

The bid documents are now complete; therefore EDA requests approval to solicit bids for construction of this project. In order to keep the project moving forward and meet project schedule commitments, staff recommends the Board of Supervisors authorize the Assistant County Executive Officer/EDA to determine award of the project in accordance with Board Policy B-11 and authorize the Chairman of the Board to execute the agreement on behalf of the Board of Supervisors, provided that the lowest bid falls within the allotted project budget amount for construction.

EDA staff recommends that the Board of Supervisors approve the plans and specifications and authorize the Clerk of the Board to advertise the Notice Inviting Bids for the project.

Impact on Citizens and Businesses

Installation of the new perimeter fencing and automatic gates at the Southwest Justice Center will allow the Sheriff to control, monitor and record vehicle and pedestrian traffic entering and exiting the facility; thus providing enhanced security for visitors, nearby residences, businesses and staff in and around the facility.
