Pursuant to Elections Code § 10515, the Board of Supervisors shall, in this case, appoint any person or persons who have filed declarations of candidacy. If no person has filed a declaration of candidacy for any office, the supervising authority shall appoint any person to the office who is qualified on the date when the election would have been held.

The Registrar of Voters certifies that the individuals recommended for appointment are qualified for the office stated, having duly filed the required documents for nomination to the respective office or qualified persons recommended by the District Board of Directors.
