SUBJECT: Appointment of Supervisor Marion Ashley to provide supervisory oversight of District 3 pending the Governor's action on the vacancy created by Supervisor Stone's election to the State Senate.

RECOMMENDED MOTION: That the Board of Supervisors:

1. Appoint Supervisor Marion Ashley to provide supervisory oversight of District 3 and act as the steward for constituent concerns until the Governor acts to fill the vacancy.

BACKGROUND:

Summary

On November 4, 2014, I was elected as Senator to the 28th District of the State of California. My last meeting as a member of the Riverside County Board of Supervisors will be November 25 and my last day in office will be November 30. Under state law, the Governor is charged with filling the vacancy created by my election to the State Senate by appointing a successor for the balance of my supervisory term which ends in 2016. There is no timetable under the law for the Governor to make the appointment.

BACKGROUND:

Summary (continued)

I am confident that he will be an exceptional steward of the District during this interim period and will allow the business of the District to continue uninterrupted.
