# **Summary (continued)**

On June 3, 2014 (Agenda Item 3.14), the Board of Supervisors authorized the Riverside County Fire Department/OES to apply for \$601,944 in Emergency Management Performance Grant (EMPG) funding on behalf of the Riverside Operational Area, per Board Policy A-30. As defined in Riverside County Ordinance No. 533 (as amended through 533.5), "Operational Area means an intermediate level of the state emergency services organization, consisting of a county and all political subdivisions within the county area." The purpose of the Emergency Management Performance Grant (EMPG) program is to support comprehensive emergency management at the State, Tribal and local levels, and to encourage the improvement of mitigation, preparedness, response, and recovery capabilities for all hazards. Funding from this grant is available to all jurisdictions through the Operational Area. The FY 2014 Emergency Management Performance Grant (EMPG) Program's allowable costs support efforts to build and sustain core capabilities across the Prevention, Protection, Mitigation, Response, and Recovery mission areas. All projects enhance and sustain Emergency Management Operations through the provision of equipment, personnel for the cities' emergency response operations and emergency operation centers, and also provide training for emergency management personnel. All matching funds are the responsibility of the awarded agency or jurisdiction.

A Budget Adjustment is attached for approval. It has been reviewed and approved by the Auditor-Controller.

#### Impact on Citizens and Businesses

These funds are used to sustain capabilities for the Riverside County Fire Department/OES and cities within the Operational Area. The Riverside County Fire Department/OES participates in many of the citizen/business groups in the capacity of providing these groups with emergency management information and training. One such training is the Community Emergency Response Team (CERT) training program which teaches citizens of the county to be self-sustaining, and have the ability to help their neighbor during a catastrophic incident.

#### SUPPLEMENTAL:

#### **Additional Fiscal Information**

Riverside County Fire Department/OES will receive \$183,995 of this grant. The dollar-for-dollar match portion of funding dedicated to the Riverside County Fire Department/OES will be derived from Emergency Services Coordinators' regular salaries that come from Net County Cost (\$183,995). Each agency that is awarded funding is responsible for providing the dollar-for-dollar cash or in-kind match requirement.

\$417,949 will be passed through to eighteen cities within the Riverside Operational Area. The match for this pass-through amount will come from 100% City funds. Riverside County Fire/OES tracks all expenses and matches. Cities provide all back-up to County Fire/OES accounting for the expenses and match. The County provides the state all of this information on a state provided expense workbook which is an excel document and shows accounting and tracking for each budgeted item. The following represents the breakdown for each city.
