BACKGROUND:

Summary (continued)

Feedback is also provided regarding the compliance status of commercial/industrial facilities to the municipal stormwater permittees through the District.

These activities are conducted in conjunction with routine inspections performed by the Department's Hazardous Materials Program and District Environmental Services program. The Department has been conducting these surveys since 2004 in Agreement with the District.

County Counsel has approved this Agreement as to legal form. A companion item appears on the County's Board Agenda this same date.

Impact on Residents and Businesses

The regulatory requirements imposed on businesses and local government by the United States Environmental Protection Agency and State of California through the NPDES stormwater program continues to escalate. This Agreement allows the District to implement a compliance program through coordination with the Department.

Contract History and Price Reasonableness

Previous Agreement between the District and the Department was for \$275,000.00. This Agreement is significantly less due to the Agreement ending December 31, 2014.
