BACKGROUND: Summary

On May 7, 2013, the Board of Supervisors adopted the 2013-2014 One-Year Action Plan of the County of Riverside's 2009-2014 Five-Year Consolidated Plan for the HUD-funded Community Planning and Development Programs. On September 26, 2014, pursuant to 24 C.F.R. § 91.520, the County prepared and submitted to the U.S. Department of Housing and Urban Development (HUD) the Consolidated Annual Performance and Evaluation Report (CAPER) for the County of Riverside's Department of Housing and Urban Development Community Planning and Development (CPD) funded programs for the reporting period July 1, 2013, through June 30, 2014. The CAPER represents a comprehensive and consolidated year-end report of the County's use of Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), and HOME Programs. The CAPER also provides a narrative summary of the performance and accomplishments during the 2013-2014 Program Year, including, but not limited to an evaluation of the performance and accomplishments of the Five-Year 2009-2014 Consolidated Plan.

Pursuant to 24 CFR § 91.105 (e), the subject public hearing is being held to obtain the views and comments of residents, service providers, local governments, and other interested parties regarding (i) the County's HUD/CPD funded programs such as the CDBG, HOME and ESG programs,(ii) the CAPER, and (iii) the identification and assessment of housing, community, social, and economic development needs in the County's communities. All public comments received will be sent to HUD.

Impact on Citizens and Businesses

The County expended \$10,367,831 in CPD program funding, including Program Income (PI), during the 2013-2014 program year. The total expenditures included \$6,061,880 of CDBG funds including Lake Elsinore (Metro City); \$3,496,395 in HOME funds; and \$809,556 in ESG funds.
