
**RECOMMENDED MOTION:** That the Board of Supervisors authorize the Waste Management Department to use Clean Energy credit cards for purchase of CNG fuel for use in Waste Management Department owned vehicles

**BACKGROUND:**

**Summary**

On March 18, 2008, the Board approved Board Policy A-62 on Credit Card Use. This policy requires a department that has an essential need to use credit cards, other than the County Procurement Card (P-Card), to have such use approved annually by the Board of Supervisors.

The Waste Management Department is requesting approval to use Clean Energy credit cards for the purchase of CNG fuel. Due to South Coast Air Quality Management District (SCAQMD) Rule 1196 for public fleet vehicles, the Department is required to purchase alternative fuel trucks such as Compressed Natural Gas (CNG). The Department has recently taken delivery of one (1) CNG truck and has three (3) additional CNG trucks on order. (continued)

**BACKGROUND:**

**Summary (continued)**

Currently, the County has limited CNG fueling infrastructure in place, with only one station located in Blythe that services CNG powered vehicles. Because of this limited availability, the Department must purchase CNG from an alternative provider. Clean Energy has CNG fueling stations located within twenty (20) miles of both the Badlands and Lamb Canyon Landfills. Additionally, Clean Energy has three (3) stations located along the I-10 corridor which will allow for fueling of these units when in use for travel to the Blythe Landfill, and more than twenty-five (25) other stations located throughout Southern California, which may be used when delivering reclaimed waste materials to recycling centers.

**Impact on Citizens and Businesses**

No impact on citizens or business is anticipated.

**SUPPLEMENTAL:**

**Contract History and Price Reasonableness**

In 2010, the Department entered into an Agreement with Clean Energy to operate the LNG facility located adjacent to the Robert A. Nelson Transfer Station that was constructed by the Department. In the agreement, Clean Energy agreed to provide the County with a discount on CNG and/or LNG consumed by Department owned vehicles ( (\$0.10/gallon LNG; \$0.15/gallon CNG).
