BACKGROUND:

Summary

On August 10, 2010, Item. 3.47, the Board of Supervisors approved the Health Net of California, Inc., (Health Net) as one of the County's Health Maintenance Organizations (HMO) and Preferred Provider Organizations (PPO) plans for the County active employees and retirees. At that time, Health Net offered the most competitive and cost-efficient plans.

In 2012, Health Net changed its Medicare Prescription Drug Plan (PDP) provider to SilverScript Insurance Company. As a result, the 2013 Agreements were delayed due to the negotiation and clarification of terms in the PDP Agreement and to ensure a Third Party Administrative Agreement between the County and Health Net, along with an Employer Group Waiver Plan Agreement between the County and SilverScript Insurance Company, was established.

The 2013 Agreements were finalized on June 3, 2014. Agreement terms for active and retiree plans have been honored since January 1, 2013. The 2014 Agreements represent the final year that the County will be contracting for medical benefits with Health Net of California, Inc. On April 22, 2014, the Board of Supervisors directed the Human Resources Department to conduct a Request for Proposal (RFP) to review current medical plans in the market to ensure the most competitive options are being offered to County employees and retirees. On July 15, 2014, the Board of Supervisors approved to select United Health Care (UHC) as replacement to Health Net. UHC offered the most competitive plan design, premiums, and innovative solutions.

Impact on Residents and Businesses

There is no direct impact to private residents or private businesses in the County of Riverside.

SUPPLEMENTAL:

Additional Fiscal Information

The 2014 plan rates were previously approved by the Board on August 20, 2013, Item 3-49 for active employees & early retirees, and on October 8, 2013, Item 3-10 for medicare eligible retirees.

The premiums were estimated to cost \$137 million in the 2014 calendar year. There is no direct cost to the County for this recommended action. Medical premiums are paid by employees and retirees.

Contract History and Price Reasonableness

Human Resources initially commenced an agreement with Health Net on January 1, 2011. Health Net was selected through a formal request for proposal (RFP) and offered the most competitive rate for the County's health plan designs. Due to the recent RFP, the Health Net medical agreement will be discontinued on December 31, 2014. Health Net will continue to provide quality service to County employees, retirees, and their dependents.

UHC, selected as the replacement medical provider for Health Net, offers County employees and retirees greater network access and lower costs on national and local levels.
