This funding will be used to sustain enhanced strength training, flexibility and circulation improvement program.
2. Animal Samaritans 6<sup>th</sup> Annual Men of The Desert Fashion Show and Charity Luncheon was held on March 7, 2015. This event raises funds for Animal Samaritans shelter and adoptions alliance rescue program. Animal Samaritans is a no-kill shelter working within a rescue program and facilitates approximately three hundred adoptions per year.
3. California State University San Bernardino Palm Desert Campus is hosting the Golf Classic tournament on April 15, 2015 to benefit student scholarships and campus development.
4. The College of the Desert Public Safety Academy provides training and educational opportunities for students to pursue a career in public safety. Each semester an outstanding cadet in Basic Peace Officer Training Module-II is selected for outstanding accomplishments and awarded a \$500 scholarship. The Basic Peace Officer Training Module II-Outstanding Cadet Award ceremony is April 20, 2015.

5. Friends of the Desert Mountains hosted the Coachella Valley Wildflower Festival on March 7, 2015. This event includes guided hikes, crafts, educational activities for all age groups, and provides material to teach visitors about the Coachella Valley. The mission of Friends of the Desert Mountains is in preserving land, supporting conservation, research in the Coachella Valley, and acting support organization for the Santa Rosa & San Jacinto Mountains National Monument.
6. The Joslyn Center will be hosting the 6<sup>th</sup> Annual Runway Fashion Show on March 26, 2015. The Joslyn Center provides critical services, care, support, and programs to local seniors. The funds raised at this event will continue to provide services.
7. Dr. Reynaldo J. Carreon Foundation is hosting the Annual Student Awards Banquet on May 15, 2015 to honor scholarship recipients and their families. The Dr. Carreon Foundation helps financially disadvantaged students of Coachella Valley through the scholarship programs.
8. Riverside County Medical Center is hosting the 3<sup>rd</sup> Annual SART/RCCAT Conference on April 22, 2015. This conference will focus on sexual assault and child abuse issues.
9. Riverside County Youth Commission's 15 Annual Youth Summit Conference will be held on March 19, 2015. This is a leadership training conference for over 400 students including at-risk and foster care students. The funds will be used to purchase copies of The Freedom Writers Diary for every attendee.
10. Riverside County Sheriff's Department is hosting their Annual Award Ceremony on April 8, 2015 honoring members of the Department and citizens of Riverside County.
11. Sky Valley Community Center building and grounds are for the benefit of the public and to serve the residents of the Sky Valley community. The community center is used for meetings of the community council, homeowners association and emergency team, and as the mobile library site. The funds will be used to replace the roof and resurface the parking lot of the community center.
12. Soroptimist House of Hope has served as a substance abuse disorder recovery facility for women in Coachella Valley for 34 years. The CID funding will be used to sustain the core program; substance use disorder recovery for women.
13. The Unforgettables Foundation is hosting Children & Family in Crisis Conference on March 21, 2015. The Unforgettables Foundation enables low-income families give their children a burial, educate parents, caregivers and communities on children's health and wholeness.
14. The Colorado River Fair Junior Livestock Auction supports the local 4-H Club and Future Farmers of America (FFA) youth in the Palo Verde Valley. CID funding will provide additional support to the 4-H Club and FFA.
15. The Riverside County Economic Development Agency used CID funds to support the Livestock Auction at the Riverside County Fair and National Date Festival on February 21, 2015.
16. The United Way of The Desert is hosting the 25<sup>th</sup> Annual Gala on May 15, 2015. All funds raised at this Gala will benefit the Community Impact Fund which supports twenty five programs in the Coachella Valley, working within the mission to break the cycle of poverty in the Coachella Valley.
