BACKGROUND:

Summary (continued)

The Sheriff's Department recognizes the importance to stay current with the safety needs of the residents of Riverside County. The County of Riverside consists of approximately 7,300 square miles, with a population of about 2.2 million residents. The Riverside County Sheriff's Department SWAT team provides SWAT services to all of the unincorporated area residents and 17 contract cities requiring it to have multiple-mission capabilities, to include terrorist and weapons of mass destruction incidents, high-risk police interventions, barricaded subjects and hostage situation.

During such incidents, it is vital to provide transportation for the necessary specialized SWAT tools and equipment. Additionally, it is necessary for the Riverside County Sheriff's Department SWAT command staff to have an area to plan, orchestrate and otherwise direct such incidents with the most accurate real-time information. The Riverside County SWAT Team is able to accomplish this with live video feeds from Department robotics and helicopters. Based on these vital public safety needs, the Riverside County Sheriff's Department SWAT team recently procured a towable SWAT Command Post.

The Riverside County Sheriff's Department SWAT Team is now seeking approval to purchase a tow vehicle with the towing capacity to support the towable Command Post. This will enable the SWAT Command Post to be available to all areas served by the Riverside County Sheriff's Department.

Via the County's bidding process, the SWAT team will provide specifications for the vehicle that will cost \$95,000 and will have the towing capacity to transport the necessary safety equipment and technological capabilities of the SWAT Command Post.

Impact on Citizens and Businesses

The Sheriff's Department is expecting that the use of the Command Post tow vehicle will provide the best opportunity to bring a quick and safe resolution to unavoidable high-risk events.
