**Summary**

Parcel number 422020003-9 is located outside the City of Moreno Valley in Supervisor Marion Ashley's District #5.

The purchase price of \$42,215.75 was determined pursuant to Section 3793.1 of the Revenue and Taxation Code, State of California, which represents the full redemption amount. The purchase price includes the cost of advertising, pursuant to Section 3793.1 (a) of the California Revenue and Taxation Code.

Please note that even after approval by the Board of Supervisors and authorization by the State Controller, the right of redemption on these properties remains until the effective date of the Agreement of Sale.

**Impact on Citizens and Businesses**

The Riverside County Waste Management Department is purchasing this property for the use of a water tank for dust control and construction.

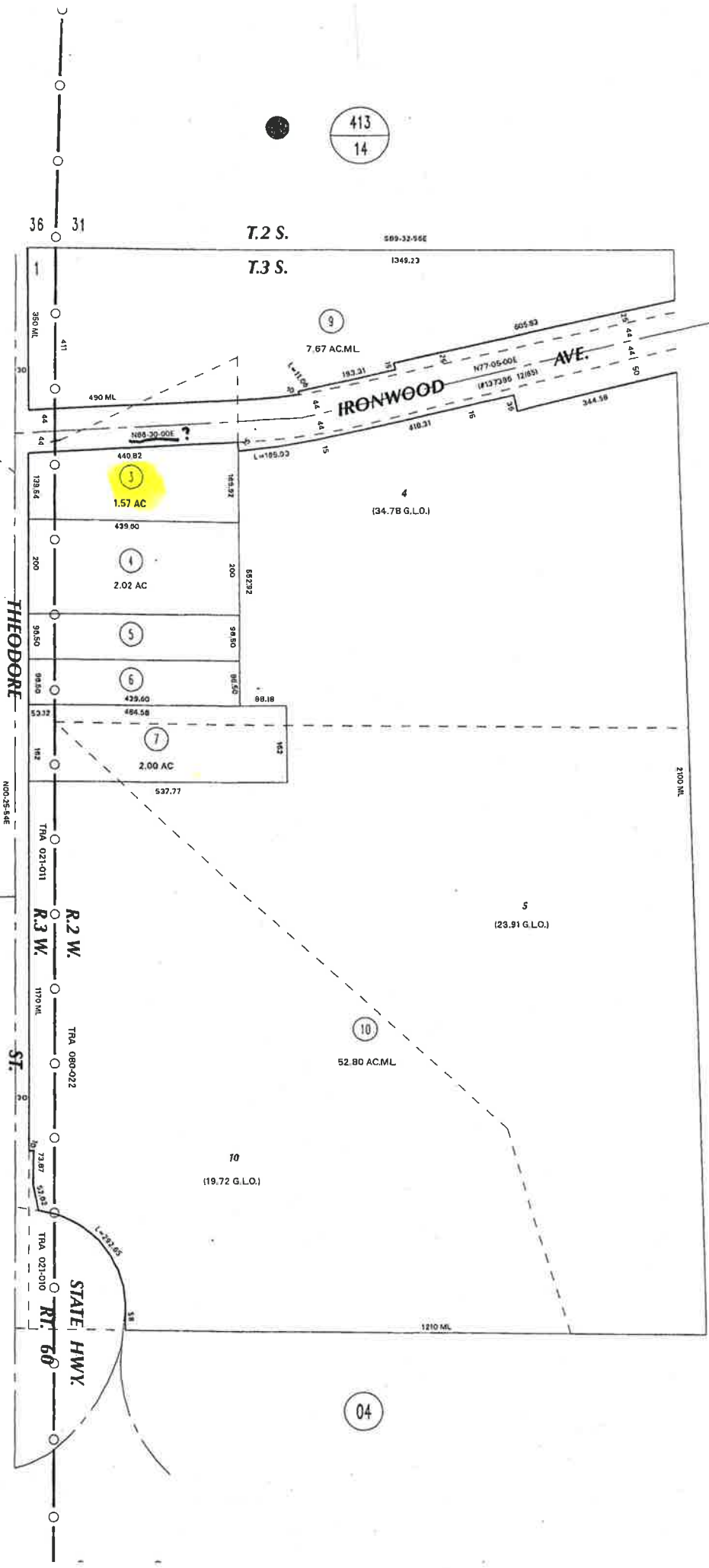
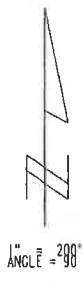
