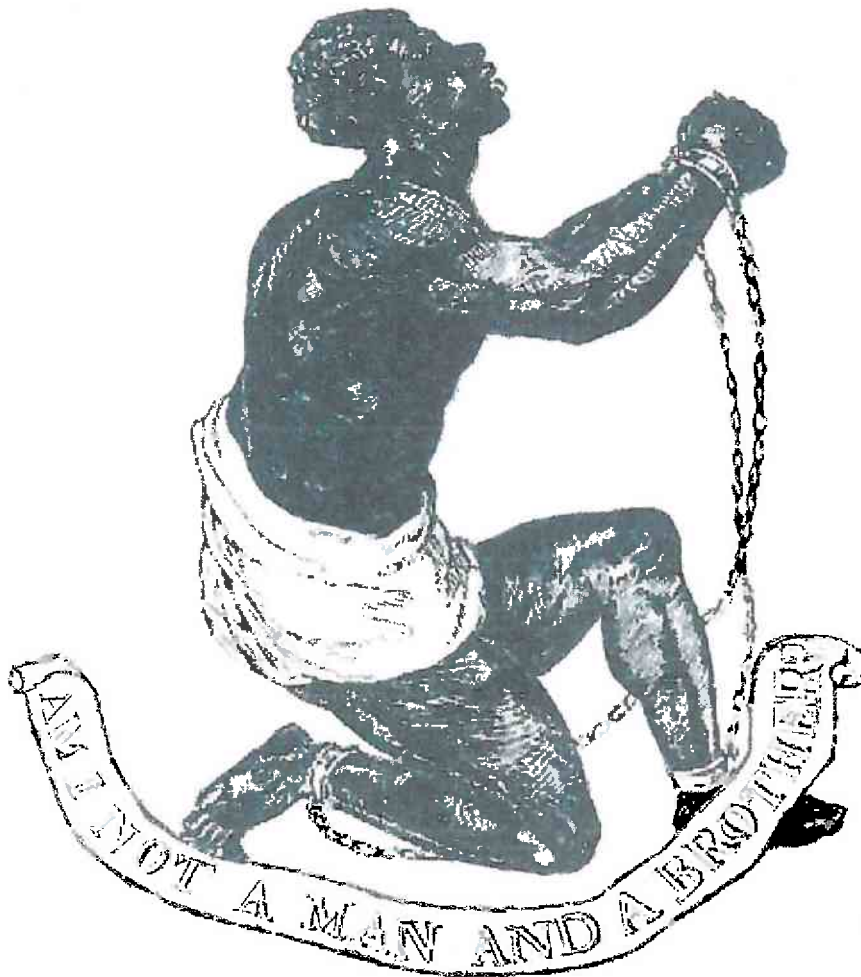

Charitable Contributions - Substantiation and Disclosure Requirements

UNDER THE NEW LAW, CHARITIES WILL NEED TO PROVIDE NEW KINDS OF INFORMATION TO DONORS. Failure to do so may result in denial of deductions to donors and the imposition of penalties on charities.

Legislation signed into law by the President on August 10, 1993, contains a number of significant provisions affecting tax-exempt charitable organizations described in section 501(c)(3) of the Internal Revenue Code. These provisions include: (1) new substantiation requirements for donors, and (2) new public disclosure requirements for charities (with potential penalties for failing to comply). Additionally, charities should note that donors could be penalized by loss of the deduction if they fail to substantiate. **THE SUBSTANTIATION AND DISCLOSURE PROVISIONS APPLY TO CONTRIBUTIONS MADE AFTER DECEMBER 31, 1993.**

Charities need to familiarize themselves with these tax law changes in order to bring themselves into compliance. This Publication alerts you to the new provisions affecting tax-exempt charitable organizations. Set forth below are brief descriptions of the new law's key provisions. The Internal Revenue Service plans to provide further guidance in the near future.

Donor's Substantiation Requirements

Documenting Certain Charitable Contributions. — Beginning January 1, 1994, no deduction will be allowed under section 170 of the Internal Revenue Code for any charitable contribution of \$250 or more unless the donor has contemporaneous written substantiation from the charity. In cases where the charity has provided goods or services to the donor in exchange for making the contribution, this contemporaneous written acknowledgement must include a "good faith estimate" of the value of such goods or services. Thus, taxpayers may no longer rely solely on a cancelled check to substantiate a cash contribution of \$250 or more.

The substantiation must be "contemporaneous." That is, it must be obtained by the donor no later than the date the donor actually files a return for the tax year in which the contribution was made. If the return is filed after the due date or extended due date, then the substantiation must have been obtained by the due date or extended due date.

The responsibility for obtaining this substantiation lies with the donor, who must request it from the charity. The charity is not required to record or report this information to the IRS on behalf of donors.

The legislation provides that substantiation will not be required if, in accordance with regulations prescribed by the Secretary, the charity reports directly to the IRS the information required to be provided in the written substantiation. At present, there are no regulations establishing procedures for direct reporting by charities to the IRS of charitable contributions made in 1994. Consequently, charities and donors should be prepared to provide/obtain the described substantiation for 1994 contributions of \$250 or more.

There is no prescribed format for the written acknowledgement. For example, letters, postcards or computer-generated forms may be acceptable. The acknowledgement does not have to include the donor's social security or tax identification number. It must, however, provide sufficient information to substantiate the amount of the deductible contribution. The acknowledgement should note the amount of any cash contribution. However, if the donation is in the form of property, then the acknowledgement must describe, but need not value, such property. Valuation of the donated property is the responsibility of the donor.

The written substantiation should also note whether the donee organization provided any goods or services in consideration, in whole or in part, for the contribution and, if so, must provide a description and good-faith estimate of the value of the goods or services. In the new law these are referred to as "quid pro quo contributions."

Please note that there is a new law requiring charities to furnish disclosure statements to donors for such quid pro quo donations in excess of \$75. This is addressed in the next section regarding Disclosure By Charity.

If the goods or services consist entirely of intangible religious benefits, the statement should indicate this, but the statement need not describe or provide an estimate of the value of these benefits. "Intangible religious benefits" are also discussed in the following section on Disclosure By Charity. If, on the other hand, the donor received nothing in return for the contribution, the written substantiation must so state.

The present law remains in effect that, generally, if the value of an item or group of like items exceeds \$5,000, the donor must obtain a qualified appraisal and submit an appraisal summary with the return claiming the deduction.

The organization may either provide separate statements for each contribution of \$250 or more from a taxpayer, or furnish periodic statements substantiating contributions of \$250 or more.

Separate payments are regarded as independent contributions and are not aggregated for purposes of measuring the \$250 threshold. However, the Service is authorized to establish anti-abuse rules to prevent avoidance of the substantiation requirement by taxpayers writing separate smaller checks on the same date.

If donations are made through payroll deductions, the deduction from each paycheck is regarded as a separate payment.

A charity that knowingly provides false written substantiation to a donor may be subject to the penalties for aiding and abetting an understatement of tax liability under section 6701 of the Code.

Disclosure by Charity of Receipt of Quid Pro Quo Contribution

Beginning January 1, 1994, under new section 6115 of the Internal Revenue Code, a charitable organization must provide a written disclosure statement to donors who make a payment, described as a "quid pro quo contribution," in excess of \$75. This requirement is separate from the written substantiation required for deductibility purposes as discussed above. While, in certain circumstances, an organization may be able to meet both requirements with the same written document, an organization must be careful to satisfy the section 6115 written disclosure statement requirement in a timely manner because of the penalties involved.

A quid pro quo contribution is a payment made partly as a contribution and partly for goods or services provided to the donor by the charity. An example of a quid pro quo contribution is where the donor gives a charity \$100 in consideration for a concert ticket valued at \$40. In this example, \$60 would be deductible. Because the donor's payment (quid pro quo contribution) exceeds \$75, the disclosure statement must be furnished, even though the deductible amount does not exceed \$75.

Separate payments of \$75 or less made at different times of the year for separate fundraising events will not be aggregated for purposes of the \$75 threshold. However, the Service is authorized to develop anti-abuse rules to prevent avoidance of this disclosure requirement in situations such as the writing of multiple checks for the same transaction.

The required written disclosure statement must:

- (1) inform the donor that the amount of the contribution that is de-

ductible for federal income tax purposes is limited to the excess of any money (and the value of any property other than money) contributed by the donor over the value of goods or services provided by the charity, and

- (2) provide the donor with a good-faith estimate of the value of the goods or services that the donor received.

The charity must furnish the statement in connection with either the solicitation or the receipt of the quid pro quo contribution. If the disclosure statement is furnished in connection with a particular solicitation, it is not necessary for the organization to provide another statement when the associated contribution is actually received.

The disclosure must be in writing and must be made in a manner that is reasonably likely to come to the attention of the donor. For example, a disclosure in small print within a larger document might not meet this requirement.

In the following three circumstances, the disclosure statement is not required.

- (1) Where the only goods or services given to a donor meet the standards for "insubstantial value" set out in section 3.01, paragraph 2 of Rev. Proc. 90-12, 1990-1 C.B. 471, as amplified by section 2.01 of Rev. Proc. 92-49, 1992-1 C.B. 987 (or any updates or revisions thereof);
- (2) Where there is no donative element involved in a particular transaction with a charity, such as in a typical museum gift shop sale.
- (3) Where there is only an intangible religious benefit provided to the donor. The intangible religious benefit must be provided to

the donor by an organization organized exclusively for religious purposes, and must be of a type that generally is not sold in a commercial transaction outside the donative context. An example of an intangible religious benefit would be admission to a religious ceremony. The exception also generally applies to de minimis tangible benefits, such as wine, provided in connection with a religious ceremony. The intangible religious benefit exception, however, does not apply to such items as payments for tuition for education leading to a recognized degree, or for travel services, or consumer goods.

A penalty is imposed on charities that do not meet the disclosure requirements. For failure to make the required disclosure in connection with a quid pro quo contribution of more than \$75, there is a penalty of \$10 per contribution, not to exceed \$5,000 per fundraising event or mailing. The charity may avoid the penalty if it can show that the failure was due to reasonable cause.

Please note that the prevailing basic rule allowing donor deductions only to the extent that the payment exceeds the fair market value of the goods or services received in return still applies generally to all quid pro quo contributions. The \$75 threshold pertains only to the obligation to disclose and the imposition of the \$10 per contribution penalty, not the rule on deductibility of the payment.

County dismantles 'hazardous' Phelan church trailers

Pastor loses land-use legal dispute

PHELAN • A four-year legal dispute between San Bernardino County and a Phelan church pastor has led to a court order enabling the county to dismantle four trailers the pastor said were

being used for church-related services.

In late February a judge granted the county the right to remove or demolish four trailers on the five-acre property on Yucca Terrace Drive, near Baldy Mesa and Phelan roads in Phelan. The court also placed the property into receivership, authorizing a lien

on the property so the receiver can recover \$32,882 in removal fees.

The Rev. Charles Linder Floyd said the Second Mount Moriah Baptist Church has already spent thousands of dollars in legal fees fighting the case.

"It has literally destroyed our church," Floyd said. "This county has run us out of the county."

Floyd said his church had been using the donated trailers as spaces to worship and host educational services and disputed county claims that they were in extremely run-down and hazardous conditions.

He had tried to fight against county code violations by citing the Religious Land Use and Institutionalized Persons Act, or RLUIPA, a federal

statute passed in 2000 aimed at preventing the government from placing a "substantial burden" on religious institutions in land-use contexts.

"That argument just never held water," county spokesman David Wert said. "The court found that the property and the types of uses that are currently on the property do not qualify for any kind of religious exemption."

The county has already torn down a trailer Floyd said was used as a classroom and begun to tear down a second, according to Floyd.

The pastor said in 2004-05 his church had up to 150 members attending weekly services. But vandalism to the church service building led the pastor to move services to his residence next door

and his membership dropped to around 100 members.

Now, Floyd "because of the fact that the county taken against church, we possibly have less than 100 members left."

The county questioned whether Floyd represented the church.

"This person claiming he's a church pastor and he's claiming he runs a school facility that he's using his property to begin to support types of activities," Wert said. "Classroom to be a church building, the appropriate use rules that apply to everyone else."

Floyd has sent letters to legislators asking them to get state Attorney General to intervene on his behalf.

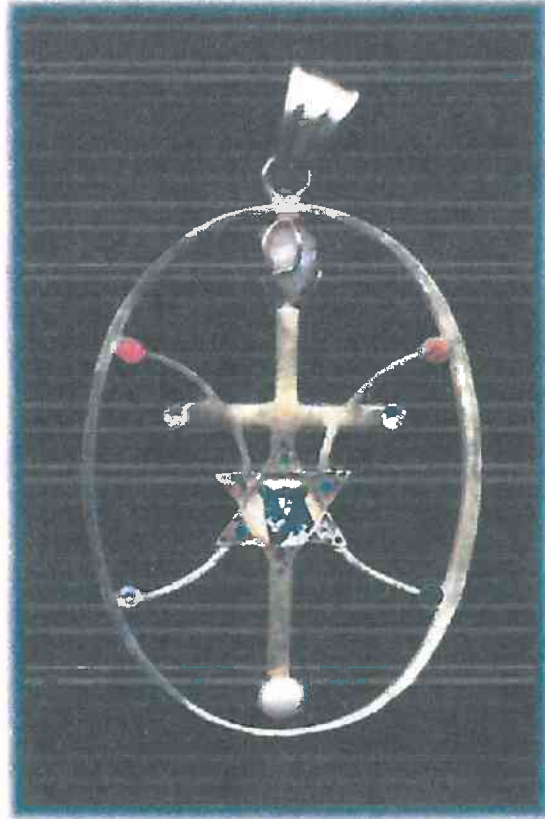

California's Power Deregulation Isn't as Open as It Looks

Many Entrepreneurs Have Signed Up, but Few Are Expected to Survive

As California moves to open electricity sales to competition on March 31, some 250 would-be marketers have signed up in the hope of making a fortune in the state's \$20 billion-a-year electric market.

Many are small businesses — and most are likely to be disappointed.

Richard Sowinski, a natural-gas-industry consultant in Martinez, Calif., already is. He was one of those who registered with the state public-utilities commission to become an official electric-service provider. He recently called it quits.

Mr. Sowinski says he concluded that the complex and still-evolving rules governing deregulation make it too expensive and difficult for small players to participate. The notion that there will be widespread competition "is nothing but a smoke-and-mirrors act," according to Mr. Sowinski.

While others aren't quite as harsh in their assessment, there is a general consensus that competition is going to sink most competitors. Among the electricity marketers, "everybody has a different strategy. The vast majority will be failures," says Bradley J. Davids of E Source Inc. in Boulder, Colo., which does research work for about 400 utilities and large power users. Mr. Davids estimates that only about 20 to 40 electricity marketers will survive.

What has attracted so many prospectors to this latest California gold rush is that, on the surface at least, electricity deregulation seems like an entrepreneurial dream. Anyone who pays a \$100 state

can start trying to sell electricity to homes and businesses around California.

Such providers can obtain electric power by signing contracts with generating firms or by purchasing from a state power exchange, where the price of electricity will fluctuate daily based on supply and demand. Actual electricity deliveries and billing will continue to be done by the existing electric utilities, which will charge the new providers a fee for such services. Theoretically, "all it takes is a telephone and computer to become a marketer of electricity," says S. Lynn Sutcliffe, a former general counsel of the U.S. Senate Commerce Committee and currently president of Sycam Enterprises of Somerset, N.J., which has signed up as an electric provider in California.

However, Mr. Sutcliffe and others say that the reality of selling electricity in California is a lot tougher. For one thing, baseline rates that will be charged by established California utilities, such as PG&E Corp.'s Pacific Gas & Electric unit and Edison International's Southern California Edison Co. unit, have already been set. And they are low enough to make it extremely difficult for newcomers to beat the price and still make a profit.

In this environment, finding low-cost supply sources, controlling costs and calculating margins becomes a sophisticated exercise, says John Schaefer, an engineering consultant in Santa Cruz, Calif. His company, Clean Power Works, has become an electric-service provider that hopes to sign up environmentally conscious customers by selling "clean" power from such sources as the sun and the wind.

Mr. Schaefer says Clean Power has signed up several thousand customers,

start-up costs for a computer system and software that he believes are needed to operate in a deregulated marketplace. Mr. Schaefer initially projected that he would need \$5 million to cover start-up costs, but soon realized that it would take much more. Clean Power's operations have been put on indefinite hold.

Others are still pushing ahead, especially marketing affiliates of the state's major electric utilities and other well-heeled energy giants, such as Houston-based Enron Corp. They and dozens of smaller firms are trying to sign up customers, ranging from big factories to individual homeowners.

But the market is still at a very early stage, and customers aren't exactly lining up to switch their electricity provider. The state's three biggest utilities, which account for about 80% of the existing electric market, say they have received requests to switch providers for only about 24,000 customers out of a total of 9.9 million.

As its name suggests, Friendly Power Co. of La Jolla, Calif., is basing its marketing on being, well, friendly, says Scott Levine, the company's chairman and co-owner. Of course, there will be low electric prices, he says. But just as important, "we will call people by their names and not put them on hold for a long time" when they call, he says. To get his message out, Mr. Levine has hired telemarketing firms and plastered the company slogan, "Know who your friends are," on billboards, coffee mugs, hats and pens.

So far, Friendly Power has signed up enough customers to produce about \$50 million to \$75 million in yearly billings,

company, which is being financed by him and his family, to have losses of some \$5 million to \$7 million in the first few years, as it builds a customer base. "Scott Levine has made a big bet on this," he says.

Financially, Charles Lindbergh Floyd has made a much smaller bet, though he may have more marketing muscle on his side. Mr. Floyd is pastor at the Second Mount Moriah Missionary Baptist Church in Lynwood, Calif., and has set up Christian Energy Electrical Co. with the idea of plowing electricity-sales profits into inner-city projects.

Mr. Floyd says his company has signed up about 500 residential and small-business customers, including some of his parishioners. Despite the competition, "if we take the old turtle approach, do a job well, we'll be in for the long haul," he says.

With so many new companies promising so much to consumers, it's perhaps inevitable that charges of misdeeds are surfacing. Late last month, the California attorney general's office filed suit in San Diego state court against Boston-Finney Inc., a Harrisburg, Pa., electric-service provider. The suit charged that Boston-Finney made "numerous untrue or misleading representations," including that it could "guarantee" the lowest electric rate, and that it had already "aligned" itself with some of the nation's biggest electricity customers.

Boston-Finney officials didn't return calls seeking comment.

Senior assistant attorney general Herschel Elkins says he fears that electricity deregulation may spawn "massive amounts of misrepresentation" in sales pitches to the public.



INTRODUCTION

At FAITHBASE.ORG CENTER ("FBOC") our mission is to families, rebuilding our schools, and saving the community through ongoing self-help programs. These outreach programs will serve individuals and families who are in need of public assistance and those who need a hand up. Our approach will be to develop families mentally and spiritually, and through education. These programs will have the same focus as our environmental efforts in bringing At-Risk Youth out of the inner cities for weekend getaways at the Phelan Petting Farm or the Perris Eco-Village Retreat.

CAMP SURVIVORS

Camp Survivors is an Eco-Village Retreat for school age children, which gives them a break from living and playing in unhealthy air. They will spend one week at the Camp learning about the environment and receive guidance in their regular studies. Accommodations are provided for the children and their teachers during their week at the Camp in areas suitable for wilderness experiences. The Education Complex's in-house programs will serve the children on a year-round basis in this western frontier setting.

Not only does S.O.R.T. educate young people about the environment, but also spiritual values – whatever their faith may be. We will be able, through Earth Day International UN-sponsored effort, to accommodate other countries educating them on methods needed to save their environment, and on developing their own inner-awareness for all people. S.O.R.T. will establish on-site environmental studies for the purpose of research and education. Our services will provide help to people from other countries who might not be economically self-supporting and help develop a viable industry for their village or land – if not individually, possibly as a group. For example, one country might have an abundance of hard wood that can be made into components of furniture that might be assembled somewhere else. All of our outreach efforts will be geared toward making other nations environmentally and economically sound, because environmental issues will not work without sound economics. These are the same issues affecting our inner cities that need sound economic structure.

MISSION STATEMENT

The Mission

We, at FAITHBASE.ORG CENTER (hereafter referred to as The Center), propose to establish an Eco-Village Retreat and Education Complex in Camelot Hills in Perris, California. Presently, we own 13.24 acres, and are in the process of obtaining the adjoining 224 acres. On this land, we plan to build a complex of buildings that will include our Headquarters, Education, Spiritual Retreats, Cultural Arts Center, and all-Sport Complex in a western frontier space-aged computerized setting. One of our primary objectives will be to educate the public on the care of our environment and on measures that can be taken to improve and/or repair the damage that has already been done. Other subjects will include Basic Education, Trades, Business, Art, Farming, Manufacturing, and Personal Management in our "dress for success training." Our goal in education is to give an understanding of the subject area and its application in real life environmental situations.

The Center will be open to all who desire and require our services. Some clients will be charged a fee, but each will be evaluated independently. We will try to accommodate as many people as possible. Our primary clients will be Parents of At-Risk Youth from the inner city, with the intention of helping them get out of the cycle of government aid by building on talents they already have, and by developing new skills. This training will help clients start their own business in reaching Third World Villages through The Center's Church-to-Village concept, and owning their own homes so that they may support their families in order to give back to their communities.

The Center's approach to helping people will focus on whole families. We will offer job training to parents, child care, parenting classes, shelter, and many other services to help produce solid family units. Some of our clients will come from sober living homes – those who are willing to take the next step to better their lives. Helping people obtain short- and long-term goals will be our marks of achievement. In their training, we will reinforce their awareness of environmental issues. This will enable them to actively participate in improving their environment with a global awareness of the World's environment.

Education Complex

Basic life values will be offered in The Center's educational programs. Subject areas will include how to establish and maintain a family, manage money, proper child care, how to buy a home, and maintain the Family. After our clients are screened and tested, they will be given a choice of fields to work in, but they must choose from the fields in which they have scored the highest aptitude. Some of the people will work for The Center, in a clean environment with very strict rules of behavior and standards which will protect everyone involved.

Housing may not be at The Center's Perris site, but all will be managed the same and have the same living requirements. One of our main training areas will be to rehabilitate properties. We will work mostly with single-family homes in the inner city. Work crews will be paid wages, but they must pay part of their room and board, and regularly invest in a savings account. The Center will match up to \$10,000 for those in the first-time home buyer's program or to start a business.

The members of the program will have first choice in buying these homes, followed by rehabilitation workers, then families with children and so forth. The sale condition would be that they live in the homes and not sell them or rent them for 10 years. If they must sell their homes, the homes must be returned to The Center at fair prices. This requirement will serve as our exit program. A couple in the program would be allowed to have two separate savings accounts, and the terms would be the same for each person. As a couple, they may use one account to buy a home and one or both may be used in order to start a business. Only one home may be purchased per couple. Other homes will be sold on the open market with the profits received by The Center. We will sell all homes and multi-family buildings will be operated on a co-op system so that single people may experience the pride of home ownership. Other areas that will generate income and serve as training by The Center will be the management of sober living homes, senior facilities and disability apartment buildings. The workers in this program will receive the same pay and savings arrangements, with the added benefit that they may buy a building at the conclusion of their training in property management. The Center will offer many other training and hands-on business opportunities that will give our clients a solid start and firm foundation in whatever vocation they choose.

Eco-Village Retreat Facilities

The Center's Eco-Village Retreat will offer lodging for up to one week at a time for individuals or groups to receive spiritual rejuvenation in a nature setting that will be designed to promote peace of mind to all guests. The goal of the Eco-Village Retreat is to offer visitors five-star service at a minimal price, while giving our workers management experience and skills that will be needed to operate their own business. After visitors come to the Eco-Village Retreat for the first time, they will return with a commitment to the whole world and in being a whole person. We will provide facilities for meetings and banquets, as well as outings and nature walks for inner city At-Risk Youth. Out of the 237.24 acres, 20 acres will be used for two man-made lakes with eight acres of lake and approximately two acres of islands for solitude. Similar to The Center's other projects, we will seek visitors from the inner city to expose them to the true gift of nature. Whether a visitor spends a day, overnight, a weekend, or an entire week, our visitors will leave rejuvenated with a new view of the world's holistic healing, nature foods, the environment around them, and what should or should not be done to it.

We will offer training in all aspects of the operation and upkeep of the Eco-Village Retreat. Workers will have the same exit program benefits, and the opportunity to buy homes or businesses when they leave and will have a renewed commitment to inner city schools. If they choose a business, they will receive follow-up support from The Center as well as help with SBA Loans. We will encourage our groups to underwrite World Bank Loans to Third World Sister-Churches or whole villages for economic growth.

The accommodations at the Eco-Village Retreat will consist of a number of one room and one bedroom suites, elegantly decorated and furnished to merit a five-star rating. This will include goods and services in order for inner-city At-Risk Youth to experience a new style of living. In keeping with the environment, all motor vehicles operated on the property must be electric, hydrogen or fuel-cell types. All other motor vehicles must be parked at the entrance. This requirement will include gas-operated lawnmowers, blowers, etc. Landscaping at The Center will be organic with no pesticides or other chemicals. Great care will be given to show our concern for the environment, because The World is One Community, and this will be our calling card.

This Eco-Village will also have other features: Banquet Rooms, a Visual Arts Center, and a Worship Room for people of all faith. All will be welcome. We at The Center will go the extra mile to accommodate and make all guests feel comfortable and welcome at all times.

The Learning Center

The Learning Center will help those without a high school diploma pass their G.E.D. test. In order for people to obtain any kind of permanent success, they must have basic knowledge and a minimum understanding of language and math skills. Not only will basic education be available, but women will also learn how to improve themselves through grooming and etiquette through our "dress for success program." Men will learn how to develop themselves as gentlemen through appearance and inward qualities of manhood. All of these subjects will involve the process of unlearning bad habits and the application of good lifestyle qualities.

Other areas of study to be offered are sound stage, recording studio production, and motion picture production. These areas are sometimes hard for inner city people to receive adequate training in and meet industry standards. However, this Perris Eco-Village Retreat is a natural setting for this facility and for movie productions. Even though this operation is on-site, it will be operated with an eye on the world needs in which we live, including immediate benefits for workers in all of our programs.

We received and reviewed your June 10, 1993 request for assistance from Lawrence Livermore National Laboratory.

Dr. Peggy Newgarden-Seals has reviewed the materials you provided her regarding your efforts to capture a significant share of the market for vehicle fleet conversion and the training/retraining of low emission vehicle technicians and mechanics.

Vehicle fleet conversion plans represent an important activity area for meeting current and future clean air standards. Vehicle technicians and mechanics represent a large and essential portion of America's workforce. Your proposal to provide a combination retraining for certificated mechanics and training for citizens aspiring to be alternative fuel vehicle mechanics to avoid skill obsolescence in the nation's vehicle fleet conversion process is important. Dr. Seals has volunteered to further explore the possibility of providing organizational and procedural assistance to help launch your effort and is currently seeking financial resources to support this interest.

As you know she has proposed that your small business participate in an applied research program - MOVES (A Multi-Occupational Vocational Education Service) which has been submitted as a proposal to the Technology Reinvestment Project for Technology Reinvestment funds. She is also exploring the possibility of obtaining a small business technical assistance agreement to conduct a needs assessment to determine what technical and infrastructure support might be available to support the Southern California Fleet Energy Independence Project's effort:

- to prepare mechanics for the conversion and maintenance of current vehicles to alternative fuel, low emission vehicles;
- to introduce the alternative vehicle market to inner cities of America;
- to establish a world wide international alternative vehicle mechanic training center,



- to achieve air quality in Los Angeles, particularly Lynwood which has been identified as the worse carbon monoxide city in the nation; and
- to enlist the Health Environment Research Institute to conduct the carbon monoxide study for health defect on impacted residents.

We have appreciated the opportunity to become more familiar with your efforts. Dr. Newgarden-Seals will continue her efforts to work with your organization and to call on us for future discussions as appropriate.


The tempo and pace of interest in alternative fuels continues to quicken, due, in large measure, to legislation such as the 1990 Clean Air Act, the Alternate Fuels Act of 1988--Clean Fuels Fleet Program, the Energy Policy Act of 1992 and Federal Executive Orders 12759 and 12844.

The EPA has designated the Los Angeles area as being one of "extreme non-attainment" (ozone). Federal funds may be withheld from those non-attainment states whose SIPs (State Implementation Plans) are inadequate to achieve the prescribed air quality standards. Such funding penalties include possible bans or sanctions on new source construction and freezes in Federal grants and highway trust funds.

As you know, the California Air Resources Board (CARB) has established the most stringent tailpipe emission standards in the nation. These new standards go into effect in 1994 and become increasingly stringent over the next 10 years. In addition, several bills have been passed (SB 135, AB 3053, SB 1071, SB 1006, AB 2766, and AB 3052) designed to move California toward meeting Federal and State clean air standards. Because California has the most stringent air quality standards, it is a fair assumption that California will, no doubt, emerge as the national leader in the use of alternative fuels for transportation.

Thus, the necessity to train and re-train the automotive/vehicular technician workforce in alternative fuel technology and applications is becoming increasingly more important and urgent. Clearly, we need to proceed with marshalling the resources necessary to expand and strengthen this kind of training now. With respect to the Lynwood site, we would appreciate receiving from you the blueprints of the old Jorgensen Steel plant at your earliest convenience. Thank you for your kind assistance in this matter.

Clergyman to Operate Housing for Elderly

A local clergyman received the go-ahead last week to operate a \$2.5-million apartment complex that will be used for senior citizens 55 and older.

The Rev. Dr. Charles Floyd, pastor of the Second Mount Moriah Baptist Church in Lynwood, received a planning commission approval to operate the 22-unit facility after city officials determined that the project will not create a negative impact on the

neighborhood.

The facility, located at 11017 Louise Ave., will have 17, two bedroom and five, one bedroom units, Floyd said.

"The facility will be different from a rest home because the occupants won't require medical attention," Floyd said. "They will be functional senior citizens who will be free to do anything they want."

The apartment units are already built except for a

central dining area that will be added.

The units were not built on their present site, but were moved onto the Louise Avenue address over a year ago under a joint venture by Rev. Floyd and CAR Development of Los Angeles.

In November 1986, Rev. Floyd paid about \$1-million to buy out CAR, bringing in Cattie Greene of Lynwood and Betty Collins of Los Angeles to form PRUD

Development and purchase the real estate.

Rev. Floyd then created Morihan Homes, a non-profit agency aimed at managing the senior adult facility.

Adequate senior citizens care, Floyd explained, is a service that is needed in Lynwood.

"Hopefully, are residents will become partners with the seniors and make the whole neighborhood safe," he said.

As a condition to receiving a permit to operate, Rev. Floyd and his heirs will be required to use the home for a senior citizen complex and have an agreement recorded by the county recorder, according to a report.

The facility comes with 29 off-street parking stalls and two spaces to accommodate the handicapped.

Seniors interested in renting one of the units can phone Rev. Floyd at 638-2286.

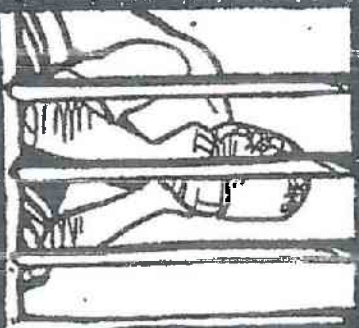

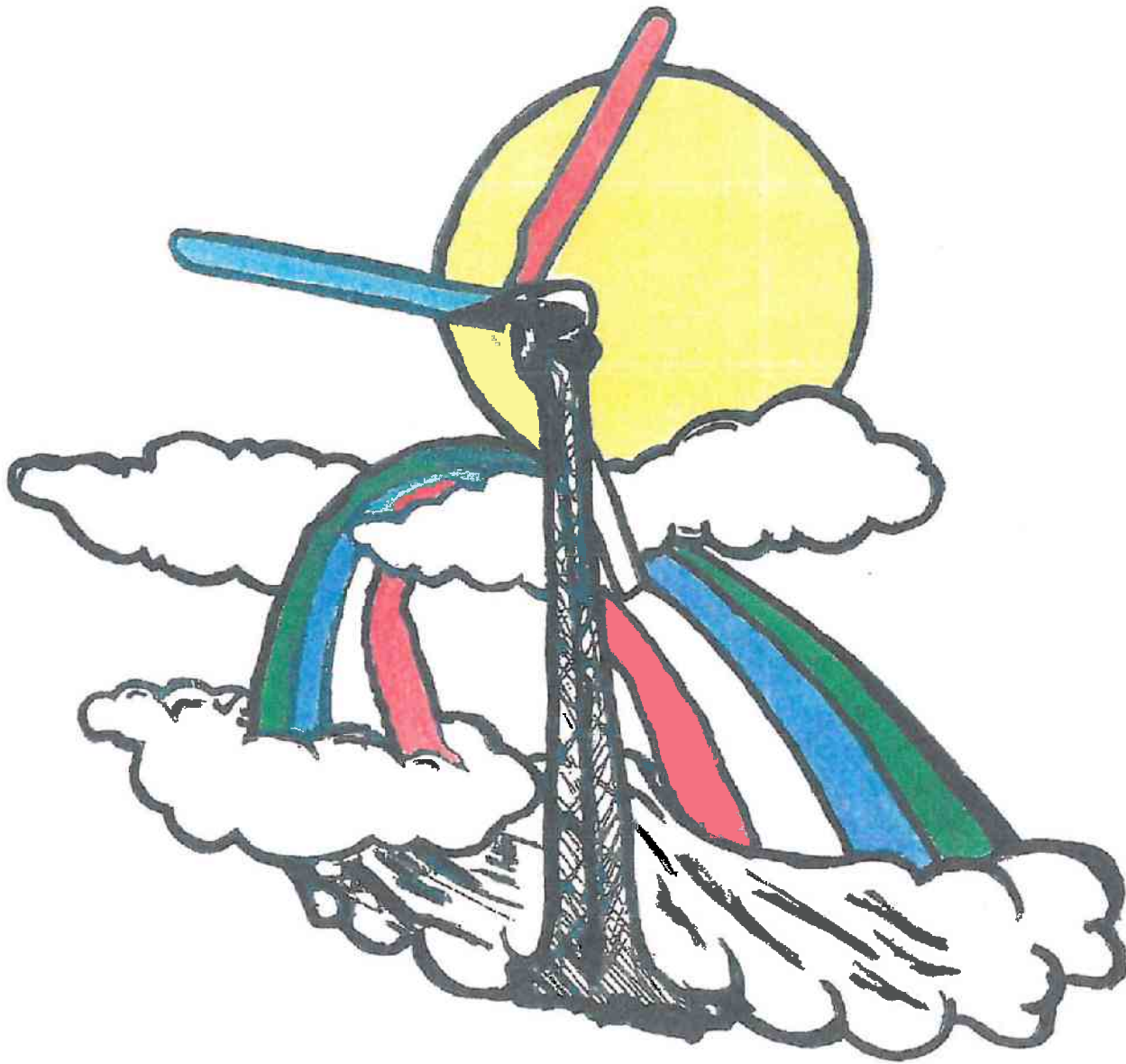

LOS ANGELES - Want to lower your electrical costs? Stop smoking. Want to serve the Lord while you pay your bill? Your electrical company will match contributions you make toward missionary work.

Those are just some of the sales pitches Californians will hear with the approach of the Jan. 1 deadline for deregulation of the electrical industry in this state.

So far, more than 100 companies from around the country have registered to sell electricity in California, which is the largest state yet to deregulate power.

Most companies are promising the cheapest electricity. But some are

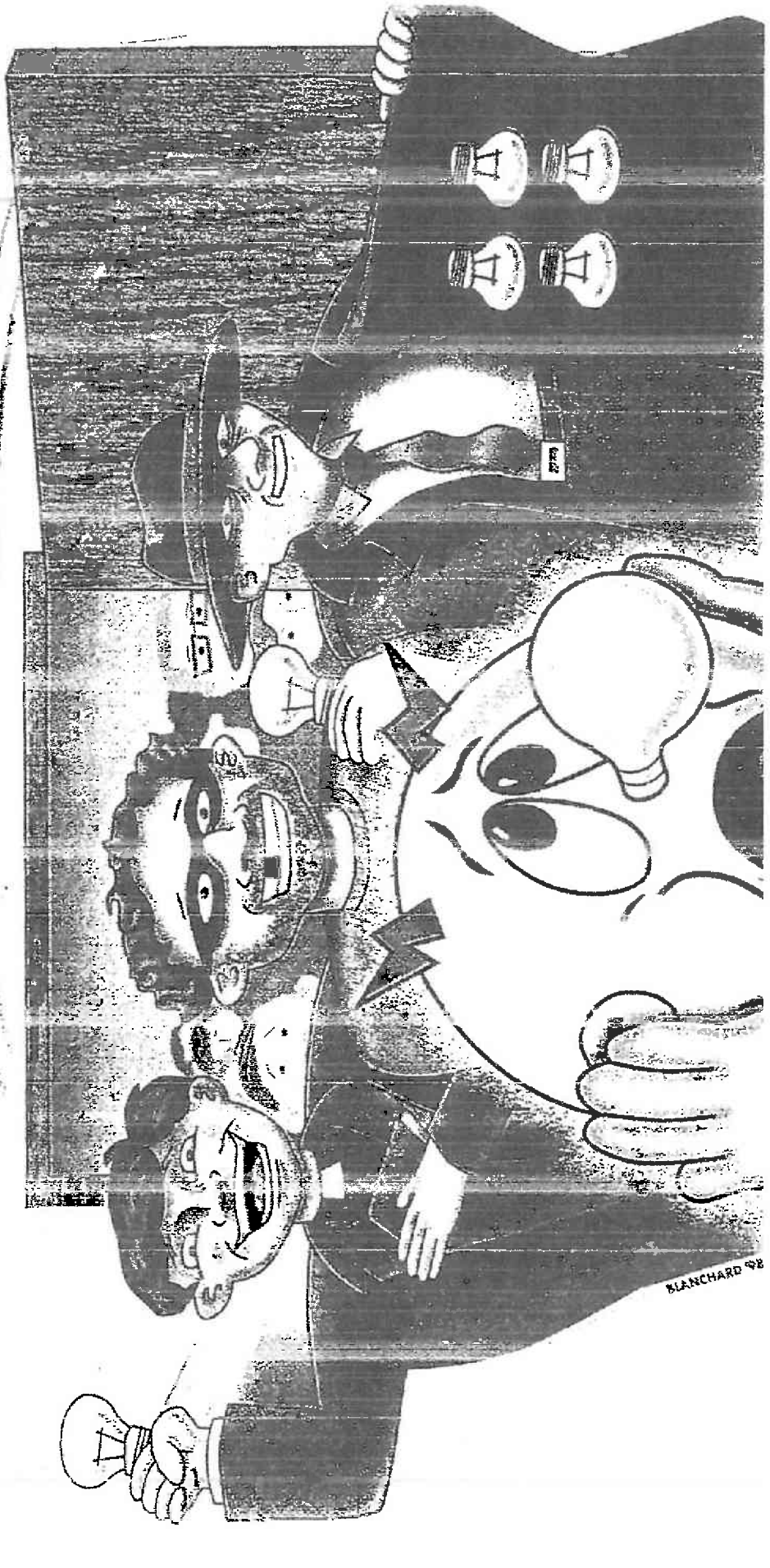

One of the last great industries to face deregulation, electricity is finally on the move. Watch California.

Energy distributors

The mantra for 1998 is deregulation: Barriers to opening up the nation's electric grid are falling state by state. None has been more aggressive than California.

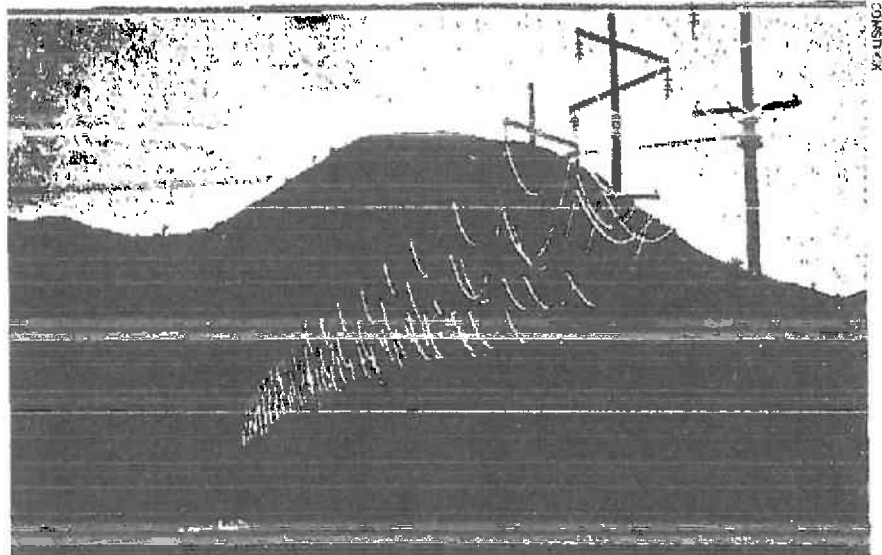
On Jan. 1 the 10 million customers of California's three biggest electric utilities gained the right to buy power from any provider. More than 200 companies, including one run by a minister who is offering redemption along with his electricity, have registered to sell power in California.

Parts of California's plan may become standard as other states deregulate. The industry's biggest fear—getting stuck with the so-called stranded costs of older, uncompetitive power plants and purchasing contracts—has been resolved. California utilities will collect a transition charge of several billion dollars a year from ratepayers until 2002. They will also receive lump-sum payments from the sale of tax-free bonds designed to ease the pain of the utilities' rate reductions.

To insure a competitive market, two California utilities were required to divest a large part of their generating capacity. Transmission lines across the state will be controlled by a new federally monitored entity. The final stretch of distribution to homes and businesses will remain controlled by the utilities and regulated by the state.

San Francisco-based PG&E Corp. expects to receive more than \$1 billion for the plants it is selling, \$3 billion from the state-run bond sale and \$1.5 billion more per year in transition charges.

Wall Street loves this kind of deregulation. PG&E's stock is up 30% since California's bill was passed last year. The hope is that deregulation will put life back into other utility stocks: Standard & Poor's utility

index has only a 47% gain over the last three years, versus 114% for the S&P 500.

The Golden State's three big utilities are pursuing divergent growth strategies. San Diego-based Enova Corp. is going the consolidation route. It's merging with Pacific Enterprises, a natural gas provider. Edison International has a big position in international energy projects. PG&E Chairman Robert Glynn Jr. is pursuing an aggressive plan to sell gas and electricity across the U.S. In 1997 PG&E spent \$3.6 billion acquiring pipelines and power-generating assets outside of California.

Beyond California, Charlotte, N.C.-based Duke Energy is on the move, with its big acquisition of Panhandle Eastern's pipelines. So are

Louisville's LG&E Energy, which is acquiring neighboring KU Energy, and Cincinnati's Cinergy, which acquired a U.K. utility. "This is a brute force industry," says Morgan Stanley Dean Witter utilities analyst Kit Konolige. "Everyone will have to grow rather aggressively." Konolige likes Duke and Cinergy as solid buys for 1998.

Deregulation of electric utilities could benefit gas companies, too. Small gas-fired power generators give gas companies a chance to take a piece of the electricity market. Firms like Pittsburgh's Consolidated Natural Gas, Las Vegas' Southwest Gas Corp. and Detroit's now Energy Group may make tempting takeover targets for their larger electric counterparts.

House of prayer and power

Minister to complete his vision with Hilltop House acquisition

APPLE VALLEY • A Phelan minister says he plans to transform the historic Hilltop House into a prayer and renewable energy center in the sky.

"This is a global initiative where the children of Apple Valley and the world will come to pray," Charles Linder Floyd, 74, said. "We'll also have mini-wind turbines set into a portion of the hill to generate power and not take away from the aesthetics and beauty of the mountain."

HILLTOP: Plans to create picnic, hiking and

Floyd, pastor of the Second Mount Moriah Missionary Baptist Church since 1967, said he began escrow on the property just south of Highway 18.

Bruin Trojan Realty of Big Bear on Tuesday confirmed that Floyd had initiated the escrow process on the property.

Floyd said he calls the vision for Hilltop House, "His Star Jew -- Dan Joshua Generation Universal Dialogue Children Center of Inclusion." It will include a replica of Jerusalem's Wailing Wall and prayer stations scattered along the hill, he said.

"What's going to make this the No. 1 attraction in the Inland Empire and North America is the replica of the historic wall," Floyd said. "We also want the town of Apple Valley to designate the road up to the house as Mount Moriah, because that is where the Temple Wall exists today."

Once his vision is complete, Floyd said, Old Testament prophecy will be fulfilled on the mountain as, "the streets of the

city shall be full of boys and girls playing in the streets thereof."

Should he acquire the property, Floyd said he plans to turn the building into his residence, and integrate a portion for Apple Valley Legacy Trail Committee's plan of transforming the house into an observation deck, and creating picnic, hiking, equine and educational areas.

Floyd said the next 60 days includes contacting the town of Apple Valley's Planning Department,

finding a contractor and architect to work on the building, and approaching the legacy group.

Floyd said he plans to work with two investors and a local financial institution for funding, including several grant options.

The nonprofit legacy group was formed last year to raise \$750,000 to purchase the hilltop structure and surrounding property.

The Hilltop House, which was once the home of Apple Valley town co-

founder Newton T. Bass, was built in 1952 with 360-degree views of the High Desert to attract potential homeowners to the growing town of Apple Valley in the '50s and '60s.

The uninhabitable house, which O.K. Doyle purchased for \$190,000 in 2000, has been abandoned and a haven for vandals, transients and hikers.

Committee member Steven Richard said Floyd had not spoken to his group, and reserved

further comments until he had more information.

In 2011, a judge granted the County of San Bernardino the right to remove or demolish four trailers on Floyd's 5-acre property in Phelan, and placed the property into receivership, authorizing a lien on the property so the receiver can recover \$32,882 in removal fees.

Floyd contended that the structures were used for church-related busi-

ness and that he had spent thousands of dollars in legal fees fighting the four-year legal dispute.

"The court found that the property and the types of uses that are currently on the property do not qualify for any kind of religious exemption," said David Wert, a county spokesman in 2011.

Historic Hilltop House boarded up

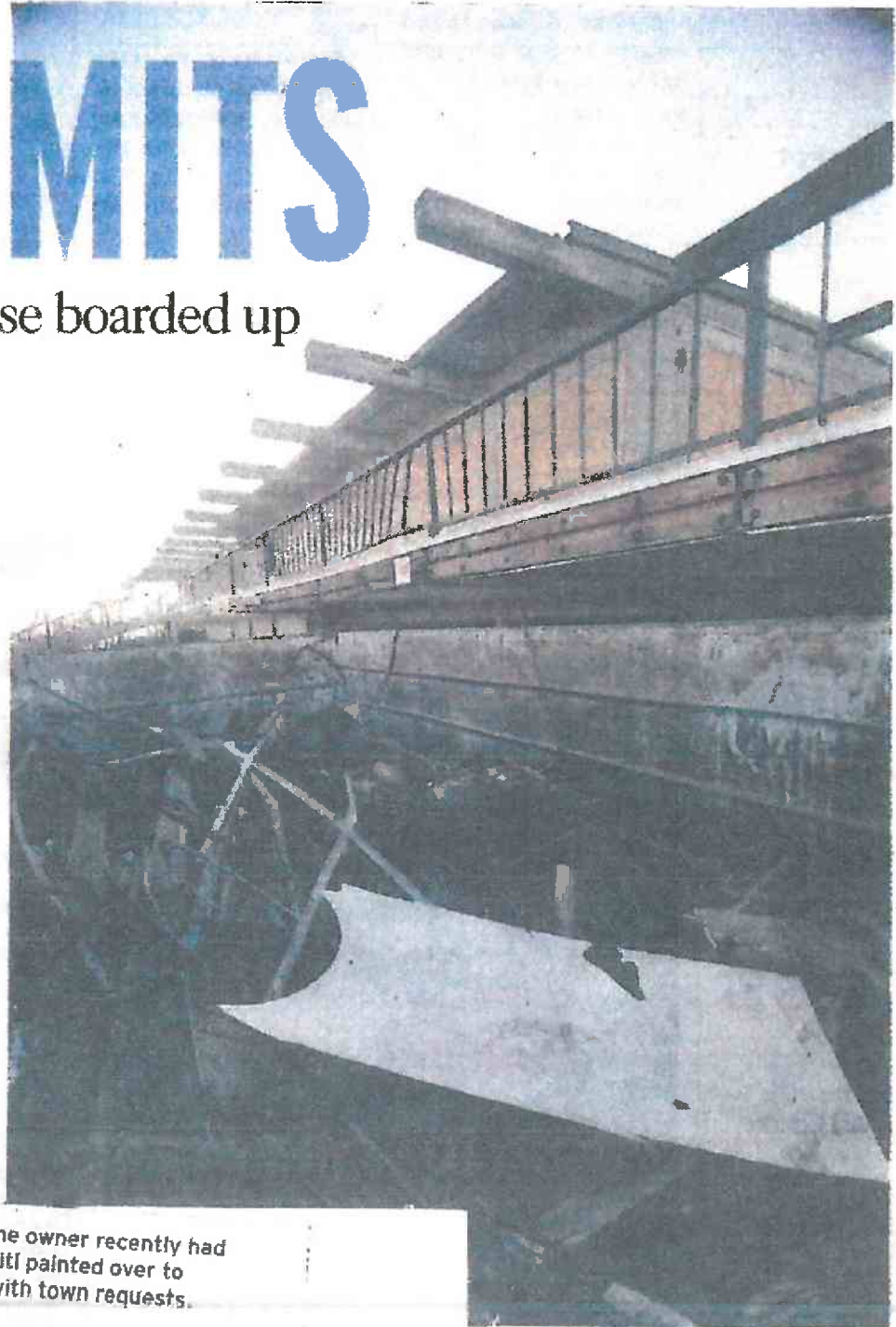
APPLE VALLEY • After years of attracting vandals, hikers and sightseers, the abandoned Hilltop House along Highway 18 has been boarded up and declared off limits.

During a recent fitness walk, Julie Pressley and her family found themselves face-to-face with someone who described himself as the owner of the property.

"He was a white-haired gentleman and he told us that it was private property and then asked us to leave," Pressley said. "He also said that the sheriff would be out to enforce this policy and that the property was too much of a liability."

Pressley, who has climbed the hill for nearly three years, said she found the house boarded up and was told by the unidentified man that the house would be for private use only.

The current owner, O.K. Doyle, purchased the house for \$190,000 in 2000. He could not be reached for comment.

The 7,200-square-foot house was boarded up sometime during the second week of October after Apple Valley officials contacted Doyle and asked that the house be secured, a town email said.

"He has complied with requests in the past and has been completely cooperative," the town statement said. "He boarded up the home and painted over all the graffiti, and is taking steps to better secure the property against trespassers."

No outstanding fines or citations have been issued, and the owner has been cooperative as he continues to make improvements, according to town officials.

"I've been climbing that hill for years without any problems, then one day the owner showed up and said 'lease leave,'"

Second. Mount Moriah Missionary Baptist Church, announced his plan to buy the property in order to transform it into a children's prayer center.

Floyd said if he acquires the property, he will use it as his residence and integrate a portion of Apple Valley Legacy Trail Committee's plan of transforming the house into an observatory deck, and creating picnic, hiking, equine and educational areas.

The nonprofit legacy trail group was formed in 2012 to raise \$750,000 to purchase the hilltop structure and surrounding property.

Floyd said several nonprofit groups have shown interest in funding and supporting the prayer center project and vision. "We are still moving

forward in the escrow process," Floyd said. "In the meantime, people are still taking liberty of trespassing on the hill and that needs to stop."

Steve Richard, of the legacy trail group, said he envisions the day when the owner, the town, his group and the citizens of Apple Valley will come together and figure out what needs to happen.

"We are grateful to Mr. Doyle and the steps he took to secure the building," Richard said. "I guess we're going to have to wait to see what happens."

The Hilltop House, once the home of Apple Valley developer Newton T. Bass, was built in 1952 to attract potential homeowners to the growing town. Bass often used the home to host Hollywood celebrities such as Bob Hope and Dean Martin.

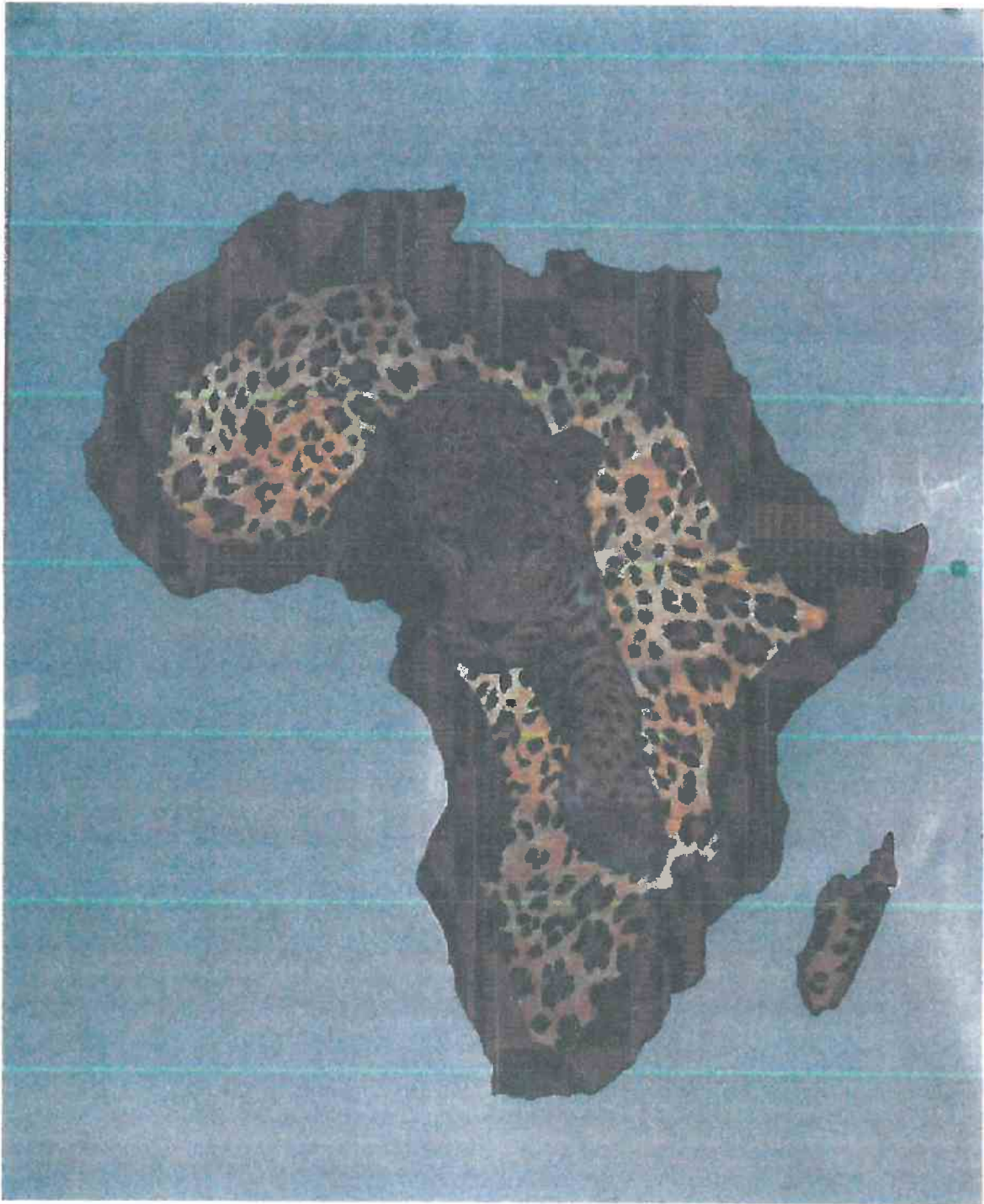



This [is] my covenant, which ye shall keep, between me and you and thy seed after thee; Every man child among you shall be circumcised. [Genesis 17:10 -

And ye shall circumcise the flesh of your foreskin; and it shall be a token of the covenant betwixt me and you. [Genesis 17:11 -

And he that is eight days old shall be circumcised among you, every man child in your generations, he that is born in the house, or bought with money of any stranger, which [is] not of thy seed. [Genesis 17:12 -

He that is born in thy house, and he that is bought with thy money, must needs be circumcised: and my covenant shall be in your flesh for an everlasting covenant. [Genesis 17:13 -

And the uncircumcised man child whose flesh of his foreskin is not circumcised, that soul shall be cut off from his people; he hath broken my covenant. [Genesis 17:14 -

And God said unto Abraham, As for Sarai thy wife, thou shalt not call her name Sarai, but Sarah [shall] her name [be]. [Genesis 17:15 -

And God said, Sarah thy wife shall bear thee a son indeed; and thou shalt call his name Isaac: and I will establish my covenant with him for an everlasting covenant, [and] with his seed after him. [Genesis 17:19 -

And as for Ishmael, I have heard thee: Behold, I have blessed him, and will make him fruitful, and will multiply him exceedingly; twelve princes shall he beget, and I will make him a great nation. [Genesis 17:20 -

But my covenant will I establish with Isaac, which Sarah shall bear unto thee at this set time in the next year. [Genesis 17:21 -

And he left off talking with him, and God went up from Abraham. [Genesis 17:22 -

And Abraham took Ishmael his son, and all that were born in his house, and all that were bought with his money, every male among the men of Abraham's house; and circumcised the flesh of their foreskin in the selfsame day, as God had said unto him. [Genesis 17:23 -

And Abraham [was] ninety years old and nine, when he was circumcised in the flesh of his foreskin. [Genesis 17:24 -

And Ishmael his son [was] thirteen years old, when he was circumcised in the flesh of his foreskin. [Genesis 17:25 -

In the selfsame day was Abraham circumcised, and Ishmael his son. [Genesis 17:26 -

And all the men of his house, born in the house, and bought with money of the stranger, were circumcised with him. [Genesis 17:27.]
