Summary

BACKGROUND

On October 31, 2014, DPSS submitted an application for Homeless Assistance funds to the U.S. Department of Housing and Urban Development (HUD) through a collaborative effort and consolidated application with the Riverside County's Continuum of Care (CoC). The Riverside County Continuum of Care is a local planning body that coordinates housing and services funding for homeless families and individuals. On January 23, 2015 HUD announced the approval of five (5) new grants and twenty-five (25) renewal grants for Riverside County's 2014 homeless projects.

In accordance with Board Resolution No. 2010.045, approved by the Board on May 25, 2010 (item 3.38), the authority to accept McKinney-Vento Homeless Assistance Act funding was delegated to the Director of DPSS. With the full execution of the attached Grant Agreements by HUD, the Grant Agreements are being submitted to the Board to ratify, receive, and file as the official copies of record. To date, twenty-eight (28) of the thirty (30) new/renewal grants have been executed by HUD. The outstanding two (2) grants will be submitted to the Board when they are received.

HUD 2014 Grant Project Descriptions

ABC Recovery – HO-02995

Permanent Supportive Housing (PSH) – CA0682L9D081407

Award Amount - \$243,001

The PSH project has 22 beds in 6 units for disabled individuals, with a priority given to chronically homeless individuals who are HIV positive, veterans, have substance abuse and other disabilities. Comprehensive assessments are given to qualifying clients for supportive needs and case management.

ABC Recovery – HO-02996

Transitional Housing (TH) – CA1134L9D081403

Award Amount - \$42,996

This project targets 40 homeless individuals that have had a history of substance/alcohol abuse or dependence. The length of stay is up to 24 months and provides comprehensive supportive services to meet clients' needs. The Transitional Housing program focuses on helping the client reach self-sufficiency and remain successful when exiting to permanent housing.

City of Riverside – HO-02998

Permanent Supportive Housing (PSH) for Chronically Homeless – CA1055L9D081404

Award Amount - \$123,652

The City of Riverside PSH project provides homes for eight chronically homeless individuals with housing and support services such as mental and health care, substance abuse services, access to benefits, employment services and basic life skills development and onsite/offsite case management and monitoring.

City of Riverside – HO-02999

Permanent Supportive Housing (PSH) for Disabled – CA0936L9D081405

Award Amount - \$121,426

The City of Riverside PSH project provides permanent supportive housing for eight disabled, homeless persons and families, with project based rental assistance, no maximum length of stay and supportive services.

City of Riverside – HO-02997

Rapid Rehousing (RRH) – CA1266L9D081401

Award Amount - \$225,612

The City of Riverside's Rapid Rehousing (RRH) is an intervention project designed to rapidly re-house a minimum of eight homeless families and/or individuals without preconditions such as: employment, income, absence of criminal record or sobriety, and helps provide the resources and services needed by each household.

County of Riverside Dept. of Mental Health (RCDMH) – (MOU) – HO-03037

Coachella Valley Permanent Supportive Housing – CA0935L9D081405

Award Amount - \$495,470

This project provides 25 beds with unlimited assistance and a low demand supportive housing component model similar to a basic Safe Haven model targeting those who are chronically homeless, disabled and diagnosed with a severe mental health diagnosis and high service needs. It is located in the north Palm Springs community. The project includes an outreach and engagement piece, with a drop in center utilized for engagement of individuals currently homeless on the streets.

County of Riverside Dept. of Mental Health (RCDMH) – HO-03039

Homeless Housing Opportunities, Partnership and Education (HHOPE) – CA1136L9D081403

Award Amount - \$469,147

A tenant based rental assistance project in scattered site housing of the individual's choice; and provides for a maximum sixty-one participants needing intensive case management support and mental health services. Targeted priorities are individuals or families who are chronically homeless, with high service needs, disabled and with a severe mental health diagnosis. Ten percent (10%) of this housing is set aside (prioritized) for homeless veterans and their families.

County of Riverside Dept. of Mental Health (RCDMH) – HO-03044

Men's Permanent Housing – CA0675L9D081407

Award Amount - \$144,284

This is a permanent housing project for chronically homeless (CH) individuals and their families that provide 20 beds in scattered site apartments. Priority is given to those individuals or families who are chronically homeless, with high service needs.

County of Riverside Dept. of Mental Health (RCDMH) – HO-03036

Rapid Rehousing – CA1263L9D081401

Award Amount - \$140,377

RCDMH provides ten units with 20 beds of tenant-based rental assistance in scattered site apartments. This project targets chronically homeless (CH) and rental assistance can be provided in 90-day increments for up to 18 months per family. The percentage of rental assistance can range from 100% to 25%, relative to the family's income needs and goal plans. The project intends to keep the assistance and support as flexible as possible to assist the family achieve personal individual goals as opposed to project goals.

County of Riverside Dept. of Mental Health (RCDMH) – HO-03048

Riverside Permanent Housing – CA0679L9D081407

Award Amount - \$358,625

RCDMH provides a permanent supportive housing project in the City of Riverside to 25 participants in a shared housing facility made up of 13 units and shared living space. This Housing First model is a low demand supportive housing for those who are chronically homeless, disabled and diagnosed with a severe mental health conditions.

County of Riverside Dept. of Mental Health (RCDMH) – HO-03051

Women's Permanent Housing – CA0684L9D081407

Award Amount - \$110,498

RCDMH provides tenant based rental assistance in scattered site housing in the community of the individual's choice. This project provides 13 units with 15 beds and overfills their units. There are no pre-conditional requirements and intensive ongoing support is provided. The target population is the chronically homeless, disabled and living with a severe mental health diagnosis.

Jewish Family Services of San Diego (JFSSD) – HO-03033

Desert Horizon Permanent Housing – CA1244L9D081401

Award Amount - \$423,680

JFSSD provides a permanent supportive housing that offers a scattered-site residential model and includes a combination of housing units, with a total of 18 beds centrally located in the Coachella Valley. Desert Horizon targets and serves chronically homeless veterans, victims of domestic violence, individuals diagnosed with substance abuse and mental illness and HIV-AIDS.

Jewish Family Services of San Diego (JFSSD) – HO-03034

Desert Vista Permanent Housing – CA0676L9D081407

Award Amount - \$671,479

JFSSD provides permanent supportive housing and has the capacity to serve a total of 40 eligible, chronically homeless (CH) and disabled individuals in Riverside County. Desert Vista does not target a specific group of homeless clients but does prioritize the chronically homeless person living with mental illness or substance abuse diagnosis, physical disabilities, HIV/AIDS, veterans, and those with multiple diagnoses and special needs. DV clients come from shelters and directly from living on the street. This project is a scattered-site residential model which includes a combination of housing units with a total of 40 beds centrally located in the Coachella Valley.

Lighthouse Social Service Centers (LHSSC) – New project – HO-03064

Rapid Rehousing – CA1367L9D081400

Award Amount - \$258,054

The Rapid Rehousing is a model of housing assistance that will move homeless families into permanent housing as quickly as possible and will assist the family in achieving stability. The proposed project goal is to provide rapid rehousing services to 12 families (40 individuals) within a 12-month period in scattered-site

housing. This project will be provided in areas identified as having limited housing services. LHSSC will provide supportive services and medium term (for 3 to 24 months) of tenant-based rental assistance to families with children, with or without disabilities and assist those families to quickly move into permanent housing and achieve stability in that housing.

Department of Public Social Services (DPSS)

Homeless Management Information System (HMIS) – CA0672L9D081407

Award Amount - \$344,072

DPSS Homeless Programs Unit is the designated HMIS Lead for the County's Continuum of Care (CoC). DPSS provides training and technical support to 23 HMIS participating agencies with a total of 125 individual HMIS users on a regular basis. Monthly users and reports training are conducted to ensure data quality, accuracy and timeliness. HMIS staff conducted users training on the new data standards and ensured that the system is operational. The system is being reviewed and bugs are reported to the vendor to fix. The HMIS Policies and Procedures undergoing revision/update based on the requirements of the new standards.

Martha's Village and Kitchen – HO-03057

Transitional Housing – CA0674L9D081407

Award Amount - \$535,000

Martha's Village and Kitchen provides 120 beds in a 34-unit dormitory-style living environment for homeless individuals and families. Of the 120 beds, 95 are for families and 25 are for single adults. A host of on-site supportive services are provided, including: healthcare, daily meals, employment assistance, education, housing placement, case management, mental health counseling, children's services (including free childcare) and alcohol/substance abuse recovery services. The project focuses on moving clients into permanent housing and increasing income through job training and employment assistance.

Operation SafeHouse – HO-03035

Transitional Housing – CA0676L9D081407

Award Amount - \$138,342

Operation SafeHouse offers transitional housing for up to 24 months for homeless youth ages 18-23. Participants live independently in one- or two-bedroom apartments and receive daily case management and supportive services, including: mental health, employment assistance, living skills education and financial education by volunteers from a local bank. SafeHouse provides clients with an apartment, food, electricity, gas, water, trash, books for school, baby supplies, all household goods, and some clothing.

Path of Life Ministries (POL) – New Project – HO-03036

Rapid Rehousing- CA1365L9D081400

Award Amount - \$338,541

POL's Rapid rehousing project targets homeless families with children, with or without disabilities, in all of Riverside County. The maximum assistance is up to 18 months. The project will provide a comprehensive RRH intervention for families that include: 1) Outreach/engagement; 2) Housing First approach; 3) Coordinated Assessment with Housing Placement (CAHP); and 4) home-based case management. Navigators will work with existing outreach teams to identify and engage families living in the streets and emergency shelters. POL uses tenant-based rental assistance (TBRA) which is a rental subsidy that is used to help homeless families with children afford housing costs. TBRA will aid in providing rental costs by making up the difference between what the household can afford. The rental assistance will be up to 18 months with a planned reduction in assistance each quarter.

Path of Life Ministries (POL) – New Project – HO-03065

Permanent Supportive Housing – CA1364L9D081400

Award Amount - \$1,278,690

POL will use a tenant-based assistance (TBA) which is a rental subsidy that will be used to help homeless families with children afford housing costs such as rent and security deposits. This project will provide 80 units (92 beds). Tenant based rental assistance will aid in providing rental costs by making up the difference between what the household can afford and the amount of the unit's fair market value. The rental assistance will be provided indefinitely for as long as needed. Supportive services will be available by choice and tenants will be encouraged to utilize them in maintaining housing and reaching self-arrived goals. Case management will be available by choice of the homeless individual or family. Once in housing, case managers/navigators will provide the sustainability services at the wish of the population addressing barriers that threaten long term

housing like healthcare, financial management, insufficient income, etc. The supportive services will include mainstream benefits, employment placement, and healthcare.

Department of Public Social Services (DPSS)

County of Riverside CoC Planning – Project Planning – CA1366L9D081400

Award Amount - \$104,365

As a Collaborative Applicant for the County of Riverside CoC, the Dept. of Public Social Services' (DPSS) is requesting planning grant funds to carry out planning activities that will focus on ensuring that homeless services throughout the county are: coordinated as a standardized system that has "no wrong door"; and integrates ESG and CoC program funding to maximize the combined impact of this funding to end homelessness in Riverside County.

Housing Authority of the County of Riverside – HO-03052

Shelter Plus Care All County #1 – CA1056L9D081404

Award Amount - \$256,552

The All County 1 grant is a Samaritan bonus project that was established to serve chronically homeless individuals with a severe and persistent mental health illness. This project serves the most visible and hardest to reach homeless individuals within the County. Supportive services are provided exclusively by the Department of Mental Health and outreach services provided by the department are an integral component of the program. Participants reside in a unit of their choosing in the private rental market via a "housing voucher" that pays a monthly housing subsidy to a local landlord. Current participants reside in all areas (incorporated and unincorporated) of the County.

Housing Authority of the County of Riverside – HO-03053

Shelter Plus Care All County #2 – CA1221L9D081402

Award Amount - \$266,052

Provides rental assistance and supportive services to chronically, homeless individuals who have experienced extended periods of homelessness on the streets. The project serves 23 chronically homeless individuals with tenant based rental assistance (TBRA) combined with intensive supportive services designed to support recovery and self-sufficiency in unlimited assistance. The 23 households are served in scattered site units throughout Riverside County. The project employs a Housing First model that offers housing without preconditions at entry as a primary component of "whole" recovery and allows participating households to return to mainstream housing within the community, supports tenant choice in rental housing, and encourages wrap around supportive services through the Department of Mental Health. Supportive services include ongoing case management, life skills training, substance abuse services, vocational rehabilitation, medical services and mental health services. The project's goals are to have at least 100% of our clients remain in permanent housing, and at least 70% of households increase their total income.

Housing Authority of the County of Riverside – HO-03054

Shelter Plus Care Consolidated All County – CA0683L9D081407

Award Amount - \$534,245

Previously funded by two separate grants, the consolidated grant was streamlined into one grant in the 2010 renewal cycle. The consolidated grant is one of the first permanent supportive housing grants funded through the Riverside County and City CoC. This grant provides permanent housing to individuals and families with a severe mental health disability. Supportive services are provided exclusively by the Department of Mental Health. Participants reside in a unit of their choosing in the private rental market via a "housing voucher" that pays a monthly housing subsidy to a local landlord. Current participants reside in all areas (incorporated and unincorporated) of the County.

Housing Authority of the County of Riverside – HO-03055

Shelter Plus Care EHOP (Permanent Housing) – CA0664L9D081401

Award Amount - \$41,935

The Enhanced Housing Opportunities Program (EHOP) was established in 2010 to provide permanent supportive housing for homeless persons with HIV who are living on the streets or in emergency shelters. It provides unlimited assistance for seven units (10 beds) and is not time limited. Participants are eligible for continued assistance if they meet their leasing obligations, participate in supportive services and still require supportive services to maintain housing. Graduating clients will be transitioned to regular Section 8. Zero income and extremely low income households may also receive a utility allowance per HUD regulations. This

Housing First model allows the most flexibility in meeting location needs especially in proximity to medical clinics and care providers as well as promoting client choice in housing which leads to greater levels of self-determination.

Housing Authority of the County of Riverside – HO-03056

Shelter Plus Care Street to Home Chronic Homeless Project – CA0666L9D081401

Award Amount - \$151,279

Housing Authority of the County of Riverside provides permanent supportive housing to thirteen (13) chronically homeless (CH) individuals that are the hardest to reach and most visible homeless individuals in our community, who have significant barriers to housing. All project participants who enter the program come from the streets. The priority is chronic homeless clients with substance abuse, mental illness or HIV AIDS diagnosis. The project works with existing homeless outreach teams, mental health clinic staff, law enforcement, code enforcement and emergency shelter staff to identify appropriate clients who may be eligible for vacant program beds. Project participants who no longer need supportive services for housing stability purposes are graduated to a regular Section 8 voucher to allow the project to serve new participants. All available project slots have been reserved for chronically homeless individuals.

US Veterans Initiative – HO-03059

Transitional Housing – CA0813L9D081406

Award Amount - \$280,238

US Vets Riverside provides a 50-bed Transitional Housing project for homeless veterans designed to help ensure a successful transition of military veterans and their families through the provision of housing, counseling, career development and comprehensive support. Veterans are offered comprehensive services and housing at the U.S.VETS facility on March Air Reserve Base in dorm style rooms. At full capacity, this residential back-to-work project focuses on obtaining employment for this high need population and also provides intensive case management, substance abuse counseling, skills development, and assistance toward acquisition of income and benefits (or increased income), while preparing them for permanent housing. Services offered are tailored to address each veteran's needs. The project connects veterans with medical, mental health, addiction treatment, and other supportive services (legal assistance, money management, relapse prevention, transportation, and therapeutic activities) through case management.

US Vets Riverside – HO-03058

Permanent Housing – CA0875L9D081403

Award Amount - \$411,590

US Vets Riverside provides permanent housing to 25 homeless disabled veterans with multiple and chronic disabilities that are significant barriers to self-sufficiency. These veterans typically are long-term substance abusers, have some form of mental illness and physical disabilities or are dually diagnosed; all factors that are exacerbated by being homeless. The project provides efficiency and 1-bedroom units in scattered sites throughout the county. Supportive services are coordinated with medical, psychiatric and substance abuse services (on/off-site) by U.S. Vets and Loma Linda VA Medical Center.

Valley Restart Shelter (VRS) – New Project – HO-03060

Rapid Rehousing – CA1368L9D081400

Award Amount - \$169,265

VRS provides rental assistance to families with children coming from homelessness using a Housing First approach for a period of 3 to 12 months. It will provide for up to eight units (20 beds) on scattered sites. VRS's program is tenant based and families will be identified through the shelter system as well as service partners such as mental health, the local police department, local food pantry, schools and other local service agencies. Rental assistance will be offered for the shortest time period needed to stabilize the family up to a total of 12 months. While in the project, the case manager will meet with the family a minimum of once a month and more as needed. Case manager/navigator will help the family address barriers such as employment, access to benefits, health issues, life skills such as budgeting, household upkeep, and ensure children are in school. Assistance will also include utility deposits and transportation assistance.

SCOPE OF WORK EXHIBIT for the FY 2014 CoC PROGRAM COMPETITION

1. This Agreement is governed by the Continuum of Care program Interim Rule attached hereto and made a part hereof as Exhibit 1a. Upon publication for effect of a Final Rule for the Continuum of Care program, the Final Rule will govern this Agreement instead of the Interim Rule. The project listed on this Exhibit at 5., below, is also subject to the terms of the FY 2014 Notice of Funds Availability.
2. This Exhibit, providing an additional award of funding, is added to the Continuum of Care Program Grant Agreement identified above by the Original CoC Program Grant Number, under the authority of the fifth paragraph of the Original CoC Program Grant Agreement. The funding provided through this Scope of Work will be referred to by the Renewal Award Number listed above.

In accordance with 24 CFR 578.105(b), Recipient is prohibited from moving more than 10% from one budget line item in a project's approved budget to another without a written amendment to this Agreement. FY 2014 CONTINUUM OF CARE PROGRAM GRANT AGREEMENT

This Grant Agreement ("this Agreement") is made by and between the United States Department of Housing and Urban Development ("HUD") and County of Riverside (the "Recipient").

This Agreement is governed by title IV of the McKinney-Vento Homeless Assistance Act 42 U.S.C. 11301 et seq. (the "Act") and the Continuum of Care Program regulation (the "Regulation").

The terms "Grant " or "Grant Funds" mean the funds that are provided under this Agreement. The term "Application" means the application submissions on the basis of which the Grant was approved by HUD, including the certifications, assurances, and any information or documentation required to meet any grant award condition. All other terms shall have the meanings given in the Regulation.

The Application is incorporated herein as part of this Agreement, except that only the project listed, and only in the amount listed on the Scope of Work, is funded by this Agreement. In the event of any conflict between any application provision and any provision contained in this Agreement, this Agreement shall control.

The Scope of Work Exhibit for the FY 2014 CoC Program Competition is attached hereto and made a part hereof. If appropriations are available for Continuum of Care grants; and if Recipient applies under a Notice of Funds Availability published by HUD; and, if pursuant to the selection criteria in the Notice of Funds Availability, HUD selects Recipient and the project for renewal, then additional exhibits may be attached to this Agreement. Those additional exhibits, when attached, will also become a part hereof.

The effective date of the Agreement shall be the date of execution by HUD and it is the date use of funds under this Agreement may begin. If the project funded by this Agreement is a new project, Recipient and HUD will set an operating start date in LOCCS for the project, which will be used to track expenditures and to determine when the project is eligible for renewal. If this Agreement renews funding for a project, the term of this Agreement shall begin at the end of the Recipient's final operating year for the grant being renewed, and eligible costs incurred for the project between the end of Recipient's final operating year under the grant being renewed and the execution of this Agreement may be paid with funds from the first operating year of this Agreement.

This Agreement shall remain in effect until termination either 1) by agreement of the parties; 2) by HUD alone, acting under the authority of 24 CFR 578.107; or 3) upon expiration of the final operating year of the project funded under this Agreement.

Recipient agrees:

1. To ensure the operation of the project listed on the Scope of Work in accordance with the provisions of the Act and all requirements of the Regulation;
2. To monitor and report the progress of the project to the Continuum of Care and HUD;
3. To ensure, to the maximum extent practicable, that individuals and families experiencing homelessness are involved, through employment, provision of volunteer services, or otherwise, in constructing, rehabilitating, maintaining, and operating facilities for the project and in providing supportive services for the project;
4. To require certification from any subrecipient that:
 - a. Subrecipient will maintain the confidentiality of records pertaining to any individual or family that was provided family violence prevention or treatment services through the project;
 - b. The address or location of any family violence project assisted with grant funds will not be made public, except with written authorization of the person responsible for the operation of such project;
 - c. Subrecipient will establish policies and practices that are consistent with, and do not restrict, the exercise of rights provided by subtitle B of title VII of the Act and other laws relating to the provision of educational and related services to individuals and families experiencing homelessness;
 - d. In the case of a project that provides housing or services to families, that subrecipient will designate a staff person to be responsible for ensuring that children being served in the program are enrolled in school and connected to appropriate services in the community, including early childhood programs such as Head Start, part C of the Individuals with Disabilities Education Act, and programs authorized under subtitle B of title VII of the Act;
 - e. The subrecipient, its officers, and employees are not debarred or suspended from doing business with the Federal Government; and
 - f. Subrecipient will provide information, such as data and reports, as required by HUD; and
5. To establish such fiscal control and accounting procedures as may be necessary to assure the proper disbursement of, and accounting for grant funds in order to ensure that all financial transactions are conducted, and records maintained in accordance with generally accepted accounting principles, if the Recipient is a Unified Funding Agency;
6. To monitor subrecipient match and report on match to HUD;
7. To take the educational needs of children into account when families are placed in housing and will, to the maximum extent practicable, place families with children as close as possible to their school of origin so as not to disrupt such children's education;
8. To monitor subrecipient at least annually;
9. To use the centralized or coordinated assessment system established by the Continuum of Care as required by §578.7(a)(8). A victim service provider may choose not to use the Continuum of Care's centralized or coordinated assessment system, provided that victim service providers in the area use a centralized or coordinated assessment system that meets HUD's minimum requirements and the victim service provider uses that system instead;

10. To follow the written standards for providing Continuum of Care assistance developed by the Continuum of Care, including the minimum requirements set forth in §578.7(a)(9);
11. Enter into a subrecipient agreement requiring subrecipient to operate the project in accordance with the provisions of this Act and all requirements under 24 CFR 578; and
12. To comply with such other terms and conditions as HUD may have established in the applicable Notice of Funds Availability.

HUD notifications to the Recipient shall be to the address of the Recipient as stated in the Application, unless HUD is otherwise advised in writing. Recipient notifications to HUD shall be to the HUD Field Office executing the Agreement. No right, benefit, or advantage of the Recipient hereunder may be assigned without prior written approval of HUD.

The Agreement constitutes the entire agreement between the parties hereto, and may be amended only in writing executed by HUD and the Recipient.


