BACKGROUND:

Summary

The Department of Public Social Services (DPSS) Adult Services Division provides access to In-Home Supportive Services (IHSS) which assist Riverside County elderly and/or disabled persons to remain safely in an independent living environment. This assistance is designed to allow persons to remain in their home rather than be placed in an institutional setting.

DPSS contracted most recently with Addus HealthCare, Inc. to provide IHSS services to approximately 700 individuals out of the more than 23,000 individuals currently authorized to receive IHSS services. The agreement with Addus covered the period July 1, 2011 through June 30, 2014, with an additional Board-approved one-year extension which provides services through June 30, 2015. This extension was requested to maintain uninterrupted services during a period of transition to the new State pilot program, Cal Medi-Connect.

To fulfill the Cal Medi-Connect directive, DPSS entered into MOUs with our designated Medi-Cal managed care plans, Inland Empire Health Plan and Molina Healthcare of California, Partner Plan, Inc. to continue the overarching duties involved in setting up and maintaining contract care or similar services. The managed care plans are to provide IHSS as a benefit of managed care through a contract with the California Department of Health Care Services. DPSS retains responsibility for the administration of the IHSS program, including determining program eligibility, conducting assessments, determining authorized hours for recipients and processing provider payroll through the State's case management system.

At the time the additional one-year extension through June 30, 2015 was requested, it was anticipated that the transition of approximately 700 Addus clients to the IHSS state payroll system could be reasonably accomplished before June 30, 2015. However, despite the partnership and combined effort of DPSS, Public Authority, the health plans and United Domestic Workers union, there are approximately 300 Addus clients who have not fully transitioned to the IHSS state payroll system. Although DPSS was statutorily required not to renew its agreement with a contract care provider upon the conclusion of its contract period, the California Department of Social Services has granted approval to DPSS to extend the contract period for another three months to ensure continuity of care through the final phases of the transition.

Given the on-going transition and in an effort to avoid any disruption in services, the Director of DPSS requests the Board authorize a three-month extension at a cost not to exceed \$1,769,148 for the period July 1, 2015 through September 30, 2015.

Impact on Residents and Businesses

These services provide much needed assistance to allow residents to remain in their home rather than be placed in an institutional setting.

Additional Fiscal Information

The funding for this contract is 100% Federal and State funding.

Contract History and Price Reasonableness

As the outcome of Request for Proposal (RFP) #DPARC-189, the Board approved the single source responder, Addus HealthCare, Inc., to provide In-Home Supportive Services for the period July 1, 2011 through June 30, 2012 for an amount not to exceed \$11,502,300 annually, with two additional option years in Agreement #AS-02155. On August 20, 2013 (Agenda #3-69) the Board approved a one-year option to the existing Addus HealthCare agreement.

The Agreement between the Riverside County Department of Public Social Services, hereinafter referred to as DPSS, and Addus HealthCare, Inc., hereinafter referred to as Contractor, is amended in the following particulars and no others:

1. DPSS and Contractor agree to renew, extend, and modify the Agreement as stated herein, inclusive of all previously executed amendments.
2. On the Recitals Page and every page thereafter, amend all references to the contract number to read, "AS-02155-11".
3. On the Recitals Page under Contract Term, amend dates to read, "July 1, 2015 through September 30, 2015".
4. On the Recitals Page under Maximum Reimbursable Amount, amend the amount to read, "\$1,769,148.00".
5. Delete Section IV.A.60 "UNIT OF SERVICE COST RATE" in its entirety and replace with, "The Unit of Service is one service hour of direct Client service and the Unit of service cost shall be \$16.88 per hour. No additional costs will be allowed.

The total amount of this Agreement shall not exceed the Maximum Reimbursable Amount (MRA) of \$1,769,148.00."
6. Amend Section V.A "GENERAL" "EFFECTIVE PERIOD", to read: "This Contract is effective July 1, 2015 through September 30, 2015."

The undersigned, as authorized representatives of DPSS and Contractor, respectively, certify the establishment of Amendment #11 to the Agreement.
