Departmental Concurrence

BACKGROUND:

<u>Summary</u>

This county's CCP Executive Committee has been active since 2011, and is in the process of finalizing its fifth annual budget. The committee comprises the following representatives: Chief Probation Officer, Chief of police, Sheriff, District Attorney, Public Defender, Presiding Judge of the Superior Court (or his/her designee), and a representative from either the County Department of Social Services, Mental Health, or Alcohol and Substance Abuse Programs, as appointed by the County Board of Supervisors.

The last position is currently filled by the Mental Health department head, who has made great contributions and served with distinction. The Board of Supervisors recently established a position of Assistant CEO of the Health System. It makes sense that the Assistant CEO who oversees the entire health system should succeed the incumbent to this position, particularly since the legislation has significant impacts on the array of county health services, including the hospital. The result of this appointment will be greater integration into navigating solutions.

Impact on Citizens and Businesses

The impact of the CCP on residents is significant, as it provides local direction and control of the transfer of certain state prison functions to counties. This action increases the scope of the executive committee's membership.
