BACKGROUND:

Summary

The public hearing for Change of Zone Case No. 7821 was scheduled as Agenda Item No. 16-1 and was held on May 12, 2015. At the conclusion of public testimony, the Board of Supervisors closed the public hearing, adopted the Mitigated Negative Declaration and tentatively approved Change of Zone Case No.7821. Pursuant to Article IV, Section 4.1 of Ordinance No. 348, the County's unincorporated area is placed in mapped zoning districts. The adoption of Ordinance No. 348.4811 will finalize the Board's tentative action, formally change the property's zoning classification and amend the County's zoning map to reflect the new zoning classification.
