SUBJECT: Authorize the Riverside County Probation Department to utilize the California Board of State and Community Corrections Standards and Training for Corrections Program Certified Trainers without obtaining competitive bids, five years. Districts All; [\$1,000,000]; State (84%), General Fund (16%)

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve and Authorize the Riverside County Probation Department to utilize the current California Board of State and Community Corrections Standards and Training for Corrections program's certified trainers (Attachment A) and future identified trainers for an aggregate amount of \$200,000 annually for five years; and,
2. Authorize the Purchasing Agent, in accordance with Ordinance No. 459, to add the State approved trainers without seeking competitive bids, to issue purchase orders that do not exceed in aggregate \$200,000 annually based on the availability of fiscal funding.

BACKGROUND:

Summary

The California Board of State and Community Corrections (BSCC), originally known as the Board of Corrections (BOC), was created in 1944 to provide leadership and coordination in local California corrections. (continued on page 2)

BACKGROUND:

Summary (continued)

The BOC set minimum standards for local adult detention facilities and operations, and had statutory responsibility for establishing selection criteria and training standards for local corrections personnel (i.e. Sheriff, Probation, Police and Department of Correction). These responsibilities continue under the BSCC and are defined in California Penal Code Sections 6024 through 6037.

The Standards and Training for Corrections (STC) program, established in 1980, is a division of the BSCC. The purpose of the STC program is to raise the level of competence of the state's local corrections and probation personnel. The program accomplishes this by developing selection and training standards; and providing a course certification and delivery system, technical assistance and support, and training to local corrections agencies statewide. In addition, participating agencies are allocated subvention funding through the STC program to offset the cost of the mandatory training. The regulations for counties and cities that choose to participate in the STC program are found in Title 15, Division 1, Subchapter 1, Articles 1 through 9, Sections 100-358 of the California Code of Regulations (CCR).

There are two categories of courses certified by STC: core training and annual training. Core training is completed at the entry-level, supervisor, and manager positions and requires up to 196 hours of core training, depending on position. As a STC participating agency, once core training is completed, the Riverside County Probation Department (Probation) sworn staff are required to maintain up to 40 hours of mandatory STC certified training annually, depending on position. In order to ensure that Probation sworn staff meet this requirement, Probation is seeking the Board of Supervisors' approval to use the trainers certified by STC, without seeking competitive bids, to schedule and pay for classes as needed.

Impact on Residents and Businesses

Mandatory annual training requirements play a major role in our community's protection efforts. Utilizing these STC certified trainers is essential to maintain staff proficiency through job-related skills training and will benefit the safety and well-being of the residents and businesses of Riverside County.

Price Reasonableness

Per the BSCC policy regarding budget, all approved/certified private providers must follow the policy with a cap to charge for services at \$100 per day per trainee or \$12.50 per hour. The cost of up to \$100.00 per trainee per day is intended to cover all course costs associated with course delivery, including instructor fees, materials, room rental, travel, and per diem. Probation is seeking the Board of Supervisors' approval to use the trainers certified by STC, without seeking competitive bid, to schedule and pay for classes as needed to meet the annual mandatory training requirement. No alternate providers are available as only those certified by STC can provide training that qualifies for the required up to 40 hours annually per sworn staff member, depending on position.

The below information is provided in support of my Department requesting approval for a sole source. Outside of a duly declared emergency, the time to develop a statement of work or specifications is not in itself justification for sole source.

- 1. Supplier being requested:** Trainers certified by the Board of State and Community Corrections (BSCC) Standards and Training for Corrections (STC) program, list of providers attached.
- 2. Supply/Service being requested:** STC program certified trainers to provide training services for the Probation Department's (Probation) sworn staff to meet their annually required up to 40 hours of mandatory STC certified training, depending on position.
- 3. Alternative suppliers that can or might be able to provide supply/service and extent of market search conducted:** No alternate providers are available as only those certified by STC can provide training that qualifies for the required up to 40 hours annually per sworn staff member, depending on position, per Title 15, Division 1, Subchapter 1, Articles 1 through 9, Sections 100-358 of the California Code of Regulations (CCR).
- 4. Unique features of the supply/service being requested from this supplier, which no alternative supplier can provide:** A trainers' uniqueness is defined by their certification by the BSCC through the STC program. For training to count towards a sworn staff's required annual training, it has to be STC certified.
- 5. Reasons why my department requires these unique features and what benefit will accrue to the county:** The Standards and Training for Corrections (STC) program raises the level of competence of the state's local corrections and probation personnel. The program accomplishes this by developing selection and training standards; and providing a course certification and delivery system, technical assistance and support, and training to local corrections agencies statewide.

There are two categories of courses certified by STC: core training and annual training. Core training is completed at the entry-level, supervisor, and manager positions and requires up to 196 hours of core training, depending on position. As a STC participating agency, once core training is completed, Probation sworn staff are required to maintain up to 40 hours of mandatory STC certified training
