
RECOMMENDED MOTION: That the Board of Supervisors:

BACKGROUND:

Summary (continued)

1. The donation to the Riverside County Medical Center Foundation will be used to sponsor their annual "Festival of Trees" which is an event benefiting all the units in the hospital that serve children. Funds raised help purchase important medical equipment including bed side x-ray machines, infant transporters, and they have replaced more than half the specialized beds in the Neonatal Intensive Care Unit.
2. The donation to Simple Acts of Care & Kindness will be used to sponsor their "World Kindness Youth Conference" where nearly 4,000 4th graders attend a day-long conference where they learn the skills of treating one another with dignity and respect with concrete steps to take in response to acts of bullying in their school.
3. The donation to the Janet Goeske Foundation will be used to sponsor their Fifty & Better Health Fair, a dynamic day of health and wellness designed specifically for community members aged 50+. The event will provide FREE high-quality health information, education, and resources essential for maintaining quality of life.
4. The donation to the Jurupa Valley High School Theater Company will be used to help the students with their fall production of Shakespeare's "Macbeth". The school does not have a budget for theater productions, and this donation will make it possible for the theater students to produce a quality high school production.
