**BACKGROUND:**

**Summary**

1. The College of the Desert Foundation has established a textbook assistance fund to provide assistance to low-income students who have no other awards, grants or subsidies and need help buying textbooks. The CID grant will be used to support the textbook assistance fund.
2. Friends of the Desert Mountains will host the annual President's barbeque on November 6, 2015 at the Monument Visitor Center in Palm Desert. This event raises funds to further expand current educational programs and develop new environmental programs targeting youth in the Coachella Valley. CID funding will be used toward catering costs.
3. Martha's Village and Kitchen provides food, clothing, counseling and shelter assistance to individuals and families who are homeless in the Coachella Valley. Martha's Village provides on-site programs including transitional housing for homeless families and individuals, daily meals and addiction and recovery services. CID funds will be used towards the cost of rent, utilities, supplies and food for the meals served.
4. The Unforgettables Foundation is a non-profit organization that gives low-income families the ability to give their child a dignified burial. The organization provides support and encouragement through financial assistance in the funeral and burial costs. CID funds will be used to assist ten families of children with these expenses.
