BACKGROUND:

Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, The Tax Collector conducted the March 20, 2012 public auction sale. The deed conveying title to the purchasers at the auction was recorded May 11, 2012. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on June 6, 2012, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest.

BACKGROUND:

Summary (continued)

The Treasurer-Tax Collector has received three claims for excess proceeds:

1. Claim from Fiore, Racobs and Powers APLC, attorneys for Palm Springs Villas Homeowners Association based on an Authorization for Agent to Collect Excess Proceeds dated February 18, 2015 and a Notice of Delinquent Assessments and Claim of Lien recorded August 5, 2011 as Instrument No. 2011-0344890.
2. Claim from the Riverside County Public Administrator, Administrator to the Estate of Paulette P. Kern based on a Declaration by Linda Samson Re: Declination to Act as Personal Representative and Nomination Executed by Kory Kocher dated September 26, 2014, a Grant Deed recorded on December 1, 2000 as Instrument No. 2000-480203, a Certification of Public Administrator's Authority to Proceed Summarily dated March, 5, 2012, a Declination to Act as Personal Representative and Nomination dated March 5, 2012, the Will of Paulette P. Kern, and the death certificate of Paulette Penny Kern.
3. Claim from Found Extra Money LLC, assignee for Kory K. Kocher, Executor to the Estate of Paulette P. Kern based on an Assignment of Right to Collect Excess Proceeds dated April 16, 2013, a Grant Deed recorded on December 1, 2000 as Instrument No. 2000-480203, the Will of Paulette P. Kern, and the death certificate for Paulette Penny Kern.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Fiore, Racobs and Powers APLC, attorneys for Palm Springs Villas Homeowners Association be awarded excess proceeds in the amount of \$15,583.43 and Riverside County Public Administrator, Administrator to the Estate of Paulette P. Kern be awarded \$14,755.62. The claim from Found Extra Money, LLC, assignee for Kory Kocher, Executor to the Estate of Paulette P. Kern be denied since Kory Kocher declined to act as the personal representative to the Estate of Paulette P. Kern on March 5, 2012. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.

Impact on Citizens and Businesses

Excess proceeds are being released to a lien holder and to the administrator of the estate of the last assessee of the property.

§ 7661. Authority of public administrator

A public administrator acting under authority of this article may:

(a) Withdraw money or take possession of any other property of the decedent that is in the possession or control of a financial institution, government or private agency, retirement fund administrator, insurance company, licensed securities dealer, or other person.

(b) Collect any debts owed to the decedent, including, but not limited to, any rents, issues, or profits from the real and personal property in the estate until the estate is distributed.

(c) Sell any personal property of the decedent, including, but not limited to, stocks, bonds, mutual funds and other types of securities. Sales may be made with or without notice, as the public administrator elects. Title to the property sold passes without the need for confirmation by the court.

(d) Sell any real property of the decedent. The sale shall be accomplished through one of the following procedures:

(1) The sale may be conducted subject to Article 6 (commencing with Section 10300) of Chapter 18 of Part 5.

(2) With approval specified in the original court order for summary disposition of the estate, the sale of real property may be accomplished using a Notice of Proposed Action according to the following requirements:

(A) The publication of the sale shall be accomplished according to Sections 10300 to 10307, inclusive.

(B) The appraisal of the property and determination of the minimum sale price of 90 percent of the appraised value shall be accomplished according to Section 10309.

(C) If an offer meets the approval of the public administrator and the offered price is at least 90 percent of the appraised value, a notice of proposed action shall be made according to Sections 10581 to 10588, inclusive. If objection is not made to the notice of proposed action, the sale may be completed without a court confirmation of the sale. The sale may be consummated by recording a public administrator's deed and a copy of the court order for summary disposition that authorized the use of the notice of proposed action.

(D) If an objection to the notice of proposed action is made pursuant to Section 10587, the sale shall be confirmed in court according to Sections 10308 to 10316, inclusive. The sale may be consummated by recording an administrator's deed and a copy of the court order confirming the sale.

(E) If objection to the notice of proposed action is not made under Section 10587, the public administrator may still elect to have the sale confirmed in court according to Sections 10308 to 10316, inclusive, if the public administrator deems that is in the best interest of the estate. Title to the property sold passes with the public administrator's deed. (*Stats.1990, c. 79 (A.B.759), § 14, operative July 1, 1991. Amended by Stats.2004, c. 888 (A.B.2687), § 8.*)
