**BACKGROUND:**

**Summary (continued)**

1. California Family Life Center / Kin Care - \$2,500 to the program which is designed to help those who are raising children of relatives and the funding will be used for family counseling, basic needs for food, shelter and clothing.
2. County of Riverside Economic Development Agency - \$1,000 funding will assist with providing the Community Indicators Report which is a valuable tool to evaluate, target and address important issues annually for the Riverside County area.
3. Rancho Damacitas - \$5,000 funding will be utilized for foster children who reside at Rancho Damacitas for their: Independent Living Program, Work Corp Training Program and Teen Leadership program.
4. Riverside County Deputy Sheriff Relief Foundation - \$1,000 to the Sheriff Relief Foundation which assists families of law enforcement and public safety officers through critical incidents, such as line of duty deaths, catastrophic life threatening illness, and provides assistance to members of the community who are victims of a criminal act.
