BACKGROUND:

Summary (continued)

On August 18, 2015, the Board approved the contract documents for the Construction of 2015 Site Improvements at the Closed Edom Hill, Beaumont, Mead Valley and Coachella Landfills, and authorized the Department to advertise for bids. On September 8, 2015, a total of three (3) bids were received, with Road Builders, Inc. submitting the lowest responsible bid. After review of the bid results, Department staff has determined that Road Builders, Inc. has the necessary experience and capability to perform the work, and County Counsel has determined that the bid documents are in order. A summary of the received bids along with the Contract Agreement between the County and Road Builders, are attached herewith.

California Environmental Quality Act (CEQA) Findings

On August 18, 2015, the Board of Supervisors approved contract documents for the construction of site improvements at the closed Edom Hill, Beaumont, Mead Valley and Coachella Landfills (Project). As such, a Notice of Exemption (NOE) was filed, identifying that the Project was exempt from CEQA pursuant to the State CEQA Guidelines Section 15061(b)(3) (General Rule for Exemption), and categorically exempt from CEQA pursuant to Section 15301 Existing Facilities and Section 15304 Minor Alterations of Land. The 35-day statute of limitations for review and comment has expired, with no comments or challenges to the NOE received. As stated in the NOE, the Project involved on-going site maintenance, drainage improvements and repairs, and security enhancements at several closed landfills with no expansion of approved uses. Since the proposed motion in this F11 simply involves the award of a contract to complete the work already assessed under the NOE, nothing further is required under CEQA.

Impact on Citizens and Businesses

Completion of the Project will improve and repair drainage structures within existing public facilities. As a result, water quality within the facilities storm water discharge shall improve. In addition, the Project will improve site security; thereby reducing occurrences of trespass. This will result in cost savings due to a reduction in maintenance costs associated with site security.

Additional Fiscal Information

Budget for this project will be provided from Fund 40200, Department ID – 4500100000.

Price Reasonableness

Due to the competitive bid process and also based on similar work performed recently at County landfills, Department engineering staff believes that the submitted bid amount is reasonable.
