- 3. If the owner or whoever has possession or control of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent of the owner or receipt of a Court Order authorizing entry onto the real property, when necessary under applicable law, may abate the accumulation of rubbish by removing and disposing of the same from the real property.
- 4. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.
- 5. County Counsel be directed to prepare the necessary Findings of Fact and Conclusions that the accumulation of rubbish on the real property is declared to be in violation of Riverside County Ordinance No. 541, and a public nuisance, and further, to prepare an Order to Abate for approval by the Board.

BACKGROUND:

- 1. An inspection was made on the subject property by Code Enforcement Officer James Pike on September 28, 2012. The inspection revealed the accumulation of rubbish on the subject property in violation of Riverside County Ordinance No. 541. The rubbish consisted of, but was not limited to: household rubbish and scrap plastic waste, in about 512 square feet.
- 2. There have been approximately thirteen (13) subsequent follow up inspections, with the last inspection occurring on June 29, 2015. The property continues to be in violation of Riverside County Ordinance No. 541.
- 3. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of accumulated rubbish.

Impact on Citizens and Businesses

Failure to abate will have a negative impact on citizens or businesses due to health and safety hazards, nuisance, and potential impact on real estate values.

I, Jamison Cole, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true, and if called as a witness, I could and would competently testify thereof under oath:

- 1. I am currently employed by the Riverside County Code Enforcement Department as a Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting properties for violations and enforcement of the provisions of Riverside County Ordinances.
- 2. I am informed and believe and thereon allege that on September 28, 2012, Officer James Pike conducted an inspection of the real property described as 55200 Hatton Place, Whitewater, Riverside County, California and further described as Assessor's Parcel Number 517-101-011. (hereinafter described as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map page indicating the location of THE PROPERTY is attached hereto and incorporated herein by reference as Exhibit "A." No accumulated rubbish is permitted.
- 3. A review of County records and documents disclosed that THE PROPERTY is owned by Yvonne S. Kruse (hereinafter referred to as "OWNER"). A certified copy of the County Equalized Assessment Roll for 2014-2015 tax year and a copy of the report generated from the County Geographic Information System ("GIS") is attached hereto and incorporated herein by reference as Exhibit "B."
- 4. Based on the Lot Book Reports from RZ Title Service dated June 18, 2014 and updated on December 23, 2014 and May 5, 2015, it is determined that other parties may potentially hold a legal interest in THE PROPERTY, to wit: Mission Springs Water Distinct and Douglas J. Kruse, (hereinafter referred to as "INTERESTED PARTIES"). True and correct copies of the Lot Book Reports are attached hereto and incorporated herein by reference as Exhibit "C."

- 5. I am informed and believe and thereon allege that on September 28, 2012, Officer Pike conducted an inspection. Officer Pike observed accumulated rubbish on THE PROPERTY which consisted of, but was not limited to the following materials: household rubbish and scrap plastic waste, in excess of 512 square feet.
- 6. As a result of the accumulated rubbish, THE PROPERTY constituted a public nuisance in violation of the provisions set forth in Riverside County Ordinance ("RCO") No. 541.
- 7. On September 28, 2012, a Notice of Violation for accumulated rubbish was posted on THE PROPERTY.
- 8. On October 15, 2012, a Notice of Violation was mailed to OWNER by certified mail, return receipt requested.
- 9. On October 22, 2014, a Notice of Violation was mailed to OWNER and INTERESTED PARTIES by first class mail and certified mail, return receipt requested.
- 10. A site plan and photographs depicting the conditions of THE PROPERTY are attached hereto and incorporated herein by reference as Exhibit "D."
- 11. A true and correct copy of each Notice issued in this matter and other supporting documentation are attached hereto and incorporated herein by reference as Exhibit "E."
- 12. There have been approximately thirteen (13) subsequent follow up inspections, with the last inspection being June 29, 2015. At each of these inspections accumulated rubbish remained on THE PROPERTY in violation of RCO 541.
- 13. Based upon my experience, knowledge and visual observations, it is my determination that the conditions on THE PROPERTY are dangerous to the neighboring property owners and the general public.
- 14. I am informed and believe and based upon said information and belief allege that the OWNER does not have legal authority or permission to store or accumulate the above described materials on THE PROPERTY.

- 15. A Notice of Pendency of Administrative Proceedings regarding the accumulated rubbish was recorded in the Office of the County Recorder, County of Riverside, State of California, on October 24, 2012, as Instrument Number 2012-0508163. A true and correct copy is attached hereto and incorporated herein by reference as Exhibit "F."
- 16. A "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing notification of the Board of Supervisors' hearing as required by RCO No. 725 was mailed to OWNER and INTERESTED PARTIES by first class mail and was posted on THE PROPERTY. True and correct copies of the Notices, together with the Proofs of Service, and the Affidavit of Posting of Notices are attached hereto and incorporated herein by reference as Exhibit "G."
- 17. Removal of all accumulated rubbish on THE PROPERTY is required to bring THE PROPERTY into compliance with RCO No. 541, and the Health and Safety Code. Under RCO No. 541, no amount of rubbish is allowed to accumulate on THE PROPERTY.
 - 18. Accordingly, the following findings and conclusions are recommended:
- (a) the accumulation of rubbish on THE PROPERTY be deemed and declared a public nuisance;
- (b) the OWNER or whoever has possession or control of THE PROPERTY, be required to remove all accumulated rubbish within ninety (90) days of the date of the posting and mailing of the Board's Order to Abate Nuisance, in accordance with all Riverside County Ordinances, including but not limited to the provision of RCO No. 541;
