BACKGROUND:

<u>Summary</u>

Change of Zone Case No. 7811 (CZ 7811) changes the zoning from Manufacturing-Service Commercial (M-SC) and Industrial Park (I-P) to One Family Dwellings (R-1) on approximately 65 acres. The public hearing for CZ 7811 was held on September 1, 2015 as Agenda Item No. 16-2. At the conclusion of public testimony, the Board of Supervisors closed the public hearing, adopted a Mitigated Negative Declaration for Environmental Assessment No. 42636 and tentatively approved CZ 7811. Pursuant to Section 4.1 of Ordinance No. 348, the County's unincorporated area is placed in mapped zoning districts. Adoption of Ordinance No. 348.7812 will finalize the Board's tentative action on CZ 7811, formally change the property's zoning classification and amend the County's zoning map to reflect the new zoning classification.




