BACKGROUND:

Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, The Tax Collector conducted the August 20, 2013 public auction sale. The deed conveying title to the purchasers at the auction was recorded October 2, 2013. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on October 30, 2013 to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest.

BACKGROUND:

Summary (continued)

Revenue and Taxation Code 4676 (b) states that the county shall make reasonable effort to obtain the name and last known mailing address of the parties of interest. Then, if the address of the party of interest cannot be obtained, the county shall publish notice of the right to claim excess proceeds in a newspaper of general circulation in the county as per Revenue and Taxation Code 4676 (c). The Treasurer-Tax Collector's Office has made it a policy to take the following actions to locate the rightful party of the excess proceeds.

- Examined title reports to notify all parties of interest attached to the parcel.
- Researched all last assessee's through the County's Property Tax System for any parties of interest.
- Used Accurint (people finder) to notify any new addresses that may be listed for our parties of interest.
- Advertised in newspapers for three consecutive weeks in the Desert Sun, Palo Verde Valley Times and the Press Enterprise referring any parties of interest to file a claim for the excess proceeds.
- Sent out a certified mailing within 90 days as required by Revenue and Taxation Code 4675.

According to Revenue and Taxation Code 4675 (a) Any party of interest in the property may file with the county a claim for the excess proceeds, in proportion to his or her interest held with others of equal priority in the property at the time of the sale, at any time prior to the expiration of the one year following the recordation of the Tax Collector's deed to the Purchaser, which was recorded on October 2, 2013.

The Treasurer-Tax Collector has received three claims for excess proceeds:

1. Claim from Moreno Valley USD CFD No. 88-1 based on an Amendment to Notice of Special Tax Lien recorded January 21, 2004 as Instrument No. 2004-0042833, a Notice of Intent to Remove Delinquent Special Tax Installments from Tax Roll recorded November 3, 2008 as Instrument No. 2008-0584169, a Notice of Intent to Remove Delinquent Special Tax Installments from Tax Roll recorded October 22, 2009 as Instrument No. 2009-0547734 and a Notice of Intent to Remove Delinquent Special Tax Installments from Tax Roll recorded December 2, 2010 as Instrument No. 2010-0577362.
2. Claim from the Riverside County Treasurer-Tax Collector based on a Certificate of Lien recorded June 11, 2007 as Instrument No. 2007-0379051.
3. Claim from Placid Development 8649 Hillside Trust based on a Tax Deed to Purchaser of Tax-Defaulted Property recorded October 2, 2013 as Instrument No. 2013-0475147.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Moreno Valley USD CFD No. 88-1 be awarded excess proceeds in the amount of \$8,902.13 and the Riverside County Treasurer-Tax Collector be awarded excess proceeds in the amount of \$1,096.46. The claim from Placid Development 8649 Hillside Trust be denied since they were not a party of interest at the time of the sale. Since there are no other claimants the unclaimed excess proceeds in the amount of \$151,568.15 will be transferred to the county general fund. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.

Impact on Citizens and Businesses

Excess proceeds are being released to the lien holders and transferred to the county general fund.



Dear Mr. Kent:

We are in receipt of the County of Riverside's Notice of the right to file a claim for excess proceeds regarding the Sale of the Tax-Defaulted Property referenced above. Our Firm represents the Moreno Valley Unified School District ("School District") with regard to Community Facilities District No. 88-1 ("CFD"). Pursuant to California Government Code Section 53356.1 *et seq.* and California Streets and Highways Code Section 3115.5, the School District holds a secured special tax lien on the property. The Notice of Special Tax Lien was recorded on February 27, 1989, as DOC# 060073 in the Official Records of Riverside County. An Amendment to Notice of Special Tax Lien was recorded on January 21, 2004, as DOC# 2004-0042833 in the Official Records of Riverside County. Neither was extinguished by the tax sale. The property will continue to be subject to the Notice and Amendment of Special Tax Lien and are a continuing obligation of the owner of the property to pay the special taxes levied on the property as they become due on an annual basis. (For your reference, a copy of the Notice and Amended Notice are attached to the Claim Form.)

The total special tax delinquencies payable for fiscal years 2006/2007, 2007/2008, 2008/2009 and 2009/2010 as of the date of the sale, August 20, 2013, were \$8,902.13. However, pursuant to Revenue & Taxation Code Section 4103, interest continues to be added at 1.5% per month until paid. The **current delinquent balance due through March 31, 2014, is \$9,287.59.** Pursuant to a Notice of Intent to Remove Delinquent Special Tax Installments From Tax Roll for each fiscal year, recorded on November 3, 2008, as DOC# 2008-0584169; October 22, 2009, as DOC #2009-0547734; and December 2, 2010, as DOC# 2010-0577362 in the Official Records of Riverside County, the delinquent special taxes were removed from the County Installment Tax Roll as part of

AMENDMENT TO NOTICE OF SPECIAL TAX LIEN
COMMUNITY FACILITIES DISTRICT NO. 88-1
OF THE MORENO VALLEY UNIFIED SCHOOL DISTRICT

Pursuant to the requirements of Sections 3114.5 and 3117.5(a) of the Streets and Highways Code and Section 53328.3 of the Government Code, the undersigned clerk of the legislative body of the MORENO VALLEY UNIFIED SCHOOL DISTRICT acting on behalf of COMMUNITY FACILITIES DISTRICT NO. 88-1 (the "District"), HEREBY GIVES NOTICE that a lien is hereby imposed on taxable property within certain territory known as Community Facilities District No. 88-1 of such District to secure payment of a special tax which the Board of Education of the Moreno Valley Unified School District, County of Riverside (the "County"), State of California, is authorized to annually levy for the following purpose:

Paying principal and interest and other costs associated with the Bonds, the proceeds of which is being used to finance the acquisition, design and construction of certain school sites and facilities; and providing moneys needed to create or replenish certain reserve funds.

The Special Tax is authorized to be levied within Community Facilities District No. 88-1 of the Moreno Valley Unified School District, which has now been officially formed, and the lien of the Special Tax is a continuing lien which shall secure each annual levy of the Special Tax and which shall continue in force and effect until the Special Tax obligation is prepaid, permanently satisfied and canceled in accordance with law or until the Special Tax ceases to be levied and a notice of cessation of Special Tax is recorded in accordance with Section 53330.5 of the Government Code.

The rate and method of apportionment of the authorized Special Tax is as shown in the Rate and Method as Exhibit "A". The Special Tax shall be collected in the same manner as ordinary ad valorem property taxes are collected and shall be subject to the same penalties and the same procedure, sale and lien priority in case of delinquency as is provided for ad valorem taxes; provided, however, the District may utilize a direct billing procedure for any Special Taxes that cannot be collected on the County tax roll or may, by resolution, elect to collect the Special

Taxes at a different time or in a different manner if necessary to meet its financial obligations. Conditions under which the obligation to pay the Special Tax may be prepaid and permanently satisfied and the lien of the Special Tax canceled are set forth in the Rate and Method of Apportionment.

Notice is further given that upon the recording of this notice in the Office of the County Recorder, the obligation to pay the Special Tax levy shall become a lien upon all non-exempt real property within Community Facilities District No. 88-1 in accordance with Section 3115.5 of the Streets and Highways Code.

The name of the owner of the real property included within the Community Facilities District No. 88-1 as it appears on the last secured assessment roll as of the date of recording of this Notice and the Assessor's tax parcel numbers of all parcels or any portion thereof which are included within the Community Facilities District No. 88-1 re as set forth on the attached, referenced and incorporated Exhibit "B."

Reference is made to the boundary of Community Facilities District No. 88-1, recorded on December 16, 1988 in Book 26, Page in the Office of the County Recorder for the County of Riverside, State of California.

This amendment amends, but does not supercede the Notice of Special Tax Lien recorded in the Recorder's Office as Document No. 1989-060073.

**Moreno Valley Unified School District
Community Facilities District No. 88-1
Special Tax Rate and Method Of Apportionment**

The Rate and Method of Apportionment is outlined in the Bond Resolutions as well as the Bond Documents. This is a summary of that information.

A Special Tax applicable to each Assessor's Parcel in Community Facilities District No. 88-1 shall be levied and collected according to the tax liability determined by the Board of Education of the Moreno Valley Unified School District acting in its capacity as the legislative body of CFD No. 88-1 (herein the "Board") through the application of the appropriate amount or rate for "Developed Property" or "Undeveloped Property", as described below. All of the property in the CFD, unless exempted by law or as indicated in Section E below, shall be taxed for the purposes, to the extent and in the manner herein provided.

A. DEFINITIONS

The terms hereinafter set forth have the following meanings:

Base Maximum Special Tax means an amount equal to \$0.10 per square foot applicable to each Developed Property except that the amount shall be \$0.07 per square foot for Developed Property in Class 1 which consists of residential lots of one-third of an acre or less for which a tentative tract map has been approved by the City of Moreno Valley as of December 6, 1988 and for which a final map is recorded so as to create no larger lots; provided however, in the event any larger lots are created from those described in the approved tentative tract map, the applicable amount shall be \$0.10 per square foot for such larger lots.

Condominium means a unit meeting the statutory definition of a condominium contained in Civil Code Section 1351.

Developed Property means all Assessor's Parcels in the CFD for which a building permit has been issued as of March 1 of the preceding Fiscal Year.

Fiscal Year means the period starting on July 1 and ending the following June 30.

Maximum Special Tax means the maximum Special Tax, determined in accordance with Section C hereof, that can be levied by the Board in any Fiscal Year for each class of Developed Property and for Undeveloped Property, as applicable.

Taxable Property is all of the area within the boundaries of the CFD, which is not exempt from the Special Tax pursuant to law or Section E below.

Townhome means an attached for-sale residential unit.

Undeveloped Property means all Taxable Property in the CFD not classified as Developed Property.

B. ASSIGNMENT TO LAND USE CLASS

On July 1 of each year, all Taxable property within the CFD shall be categorized either as a Developed Property or an Undeveloped Property and shall be subject to tax in accordance with the rate and method of apportionment determined pursuant to Sections C and D below.

For purposes of determining the applicable Maximum Special Tax pursuant to Section C, Developed Property shall be assigned to Classes 1 through 3 based upon the square footage for the improvements to be constructed on an Assessor's Parcel as set forth on the building permit issued for such property. The square footage of a structure assigned to Classes 1 through 3 shall be calculated by measuring the internal living space of each unit located within the Assessor's Parcel, exclusive of garages or other structures, which are not used as living spaces. Commercial and industrial property shall be assigned to Class 4. The square footage of a commercial or industrial building assigned to Class 4 shall be computed from the gross square footage for the building as reflected in the building plans upon which the building permit was issued.

C. MAXIMUM SPECIAL TAX RATE

DEVELOPED PROPERTY

The Maximum Special Tax for an Assessor's Parcel classified as Developed Property in Classes 1 through 4 shall be the greater of i) the amount derived by multiplying the square footage of such Assessor's Parcel times the Base Maximum Special Tax or ii) the amount determined by reference to Table 1. For purposes of this Section C, the acreage or square footage of an Assessor's Parcel shall be determined by reference to the most current parcel map or other subdivision tract map recorded with the Office of the County Recorder for Riverside County.

UNDEVELOPED PROPERTY

The Maximum Special Tax for Undeveloped Property shall be \$6,200 per acre.

In making the computations set forth in this Section C and in determining the Maximum Special Tax which may be levied in any Fiscal Year, on July 1, 1990 and on each July 1 thereafter, the Base Maximum Special Tax and the Maximum Special Tax for Developed Property contained in Table 1 and for Undeveloped Property shall be increased by an amount equal to 3.0% of the amount in effect for the previous Fiscal Year.

D. METHOD OF APPORTIONMENT OF THE SPECIAL TAX TO DEVELOPED PROPERTY AND UNDEVELOPED PROPERTY.

Starting in Fiscal Year 1989/90 and for each following Fiscal Year, the Board shall determine the amount of money to be collected from Taxable Property in the CFD in that Fiscal Year. Such amount shall include the sums necessary to pay current debt service on the indebtedness of the CFD, to create or replenish reserve funds determined necessary by the CFD for existing or future indebtedness, and to pay administrative and construction expenses, and any services to be paid from the Special Tax proceeds. The Board shall levy the Special Tax as follows until the amount of levy equals the amount to be collected:

First: The Special Tax shall be levied on Developed Property in equal percentages up to 100% of the applicable rate for each class for such Fiscal Year, determined by reference to Table 1;

Second: If additional moneys are needed after the first step has been completed, the Special Tax shall be levied proportionately on each parcel of Undeveloped Property (exclusive of Undeveloped Property owned by or offered for dedication to a public agency or owned by a public utility for use as an unmanned facility, or by a homeowner's association, or open space being used as a golf course) up to \$6,200 per acre;

Third: If additional moneys are needed after the first two steps have been completed, then the levy of the Special Tax on each Assessor's Parcel of Developed Property whose Maximum Special Tax is determined through the applications of the Base Maximum Special Tax shall be increased up to the Maximum Special Tax for each such Assessor's Parcel by increasing the applicable rate for each class for such Fiscal Year determined by reference to Table 1 in equal percentages above the rates levied pursuant to step one above;

Fourth: If additional moneys are needed after the first three steps have been completed, then the Special Tax shall be levied proportionately on each parcel of Undeveloped Property offered for dedication to a public agency or owned by a homeowner's association, or open space being used as a golf course which has not been exempted from the Special Tax pursuant to Section E, up to the Maximum Special Tax for Undeveloped Property; and

Fifth: If additional moneys are needed after the first four steps have been completed then the Special Tax shall be levied proportionately on each parcel of Undeveloped Property conveyed to a public agency which has not been exempted from the Special Tax pursuant to Section E, up to the Maximum Special Tax for Undeveloped Property.

E. LIMITATIONS

The Board shall not impose any Special Tax on up to 450 acres of land conveyed or irrevocably offered for dedication to a public agency or owned by a public utility for use as an unmanned facility or by a homeowner's association, or open space being used as a golf course. If the total number of acres of land conveyed or irrevocably offered for dedication to a public agency or owned by a public utility for uses as an unmanned facility or by a homeowner's association, or open space being used as a golf course exceeds 450 acres, then the exempt acres shall be determined in the following order of priority, with the property within each category receiving priority based on the date that it entered such category: 1) property owned by a public agency for public right of way or property which is an unmanned utility property, 2) other property owned by a public agency, 3) property irrevocably offered for dedication to a public agency, and 4) property owned by a homeowner's association, or 5) property which is open space used as a golf course. The acres exceeding such total of 450 shall be taxed as Undeveloped Property to the extent set forth in steps four and five in Section D above; provided, however, that in no event shall the Board impose a Special Tax on land which is a public right of way or which is an unmanned utility property or property encumbered with public or utility easements making impractical its utilization for other than the purpose set forth in the easement.
