BACKGROUND:

Summary

Departmental Concurrence

Change of Zone Case No. 7739 (CZ 7739) changes the zoning from Light Agricultural - 5 Acre Minimum (A-1-5) to Planned Residential (R-4) on approximately 53.94 gross acres. The public hearing for CZ 7739 was held on November 4, 2014 as Agenda Item No. 16-2. At the conclusion of public testimony, the Board of Supervisors closed the public hearing, adopted a Mitigated Negative Declaration for Environmental Assessment No. 41782 and tentatively approved CZ 7739. Pursuant to Section 4.1 of Ordinance No. 348, the County's unincorporated area is placed in mapped zoning districts.

Adoption of Ordinance No. 348.4819 will finalize the Board's tentative action on CZ 7739, formally change the property's zoning classification and amend the County's zoning map to reflect the new zoning classification.


R-4 LEGEND




