BACKGROUND:

Summary (continued)

Fred Waring Drive is a regional arterial road as identified in the original Measure “A” Transportation Program and is identified as a six-lane facility in Coachella Valley Association of Governments (CVAG) Regional Arterial Program. This segment of Fred Waring Drive between Adams Street and Port Maria Road is the final remaining segment and it completes Fred Waring Drive as a six-lane regional arterial road.

The originally authorized amount of the contract was \$5,996,520. The total amended contract is \$6,383,278, which is 6.4% more than the originally authorized amount. The (5) contract change orders, which totaled 5.8% of the contract amount, provided compensation to the contractor for various changes to the project which have been summarized in the attached change order report. The majority of the change orders were related to modifications necessary to maintain, transition, and restore homeowner facilities along the north side of the road widening. The 0.6% increase in the bid item quantities was primarily attributed to an increase in the asphalt paving required to complete the work.

The work was completed at the direction of the Riverside County Transportation Department (Transportation Department) on August 1, 2014, Work Order number B5-0689 and State Aid number SLPPCL13-5956 (220).

Impact on Residents and Businesses

The road was widened approximately five feet on the south side and included the construction of a sound wall for the homes on the southerly side. A parking lane on the north side will allow for safe turning into and out of the residential driveways. This project completes the original Measure “A” list of projects in the Coachella Valley, and was completed at a fraction of the cost and with less impact on adjacent residences, than it would have taken to purchase homes and do a traditional road widening.

Contract History and Price Reasonableness

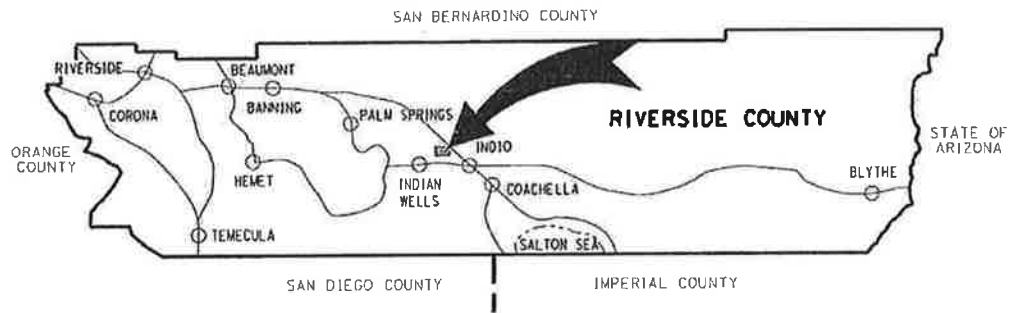
Two bids were received ranging from \$5,996,520 to \$7,041,407. The basis for the selection of a contractor is the lowest responsive and responsible bid. The lowest responsible bid was submitted by Granite Construction Company in the amount of \$5,996,520, which was \$537,071 (8%) below the Engineer's Estimate. The final amended contract amount is \$6,383,278 which is 2.3% below Engineer's Estimate.

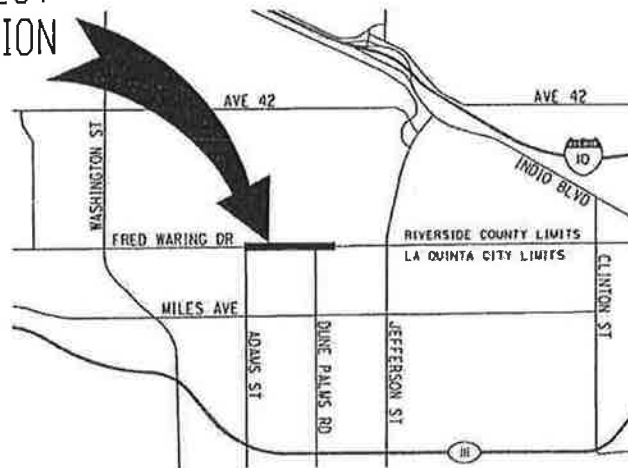
Vicinity Map

1	\$50,000	0.83%	Concrete encase existing IID electrical conduits to avoid costly utility relocation fees; Modification to existing landscape irrigation systems for several residences in order to maintain existing landscape watering during construction; 21 individual mailboxes had to be relocated for safety concerns raised by the postmaster; Reimbursement to the contractor for the payment to the State Water Control Resources Board to expedite the acquisition of the Project WDID number.
