#### **BACKGROUND:**

**Summary** 

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, The Tax Collector conducted the February 4, 2014 public auction sale. The deed conveying title to the purchasers at the auction was recorded March 21, 2014. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on April 22, 2014 to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest.

# BACKGROUND: Summary (continued)

The Treasurer-Tax Collector has received one claim for excess proceeds:

1. Claim from Global Discoveries, Ltd., assignee Otaveyon Monyea Johnson based on an Assignment of Right to Collect Excess Proceeds dated April 25, 2014 and a Grant Deed recorded July 31, 1989 as Instrument No. 254370.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Global Discoveries, Ltd., assignee Otaveyon Monyea Johnson be awarded excess proceeds in the amount of \$44,433.53. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimant by certified mail.



I wanted to touch base with you in regards to the above referenced file we claimed on behalf of Mr. Johnson. Sorry for the delay in responding to your questions/concerns but our client is incarcerated so a bit hard to get a hold of to obtain information.

After speaking with Mr. Johnson he has advised us that he is not a Jr., his father's name is Eddie Johnson, we confirmed this information by obtaining a copy of his Certificate of Live Birth (**Please see attached**). Octaveyon also provided us a copy of a Water Bill referencing the Situs property of 390 PALM VISTA DR PALM SPRINGS CA 92262. (**Please see attached**).
