Summary

Due to the construction of the Airport Boulevard Railroad Grade Separation, a portion of Airport Boulevard has been realigned. The portion of old Airport Boulevard between Polk Street and Grapefruit Boulevard is required for local access and remains as a connector road to Grapefruit Boulevard. This portion of the old alignment is to be renamed Airport Frontage Road

22 **Boulevard** as required by law.

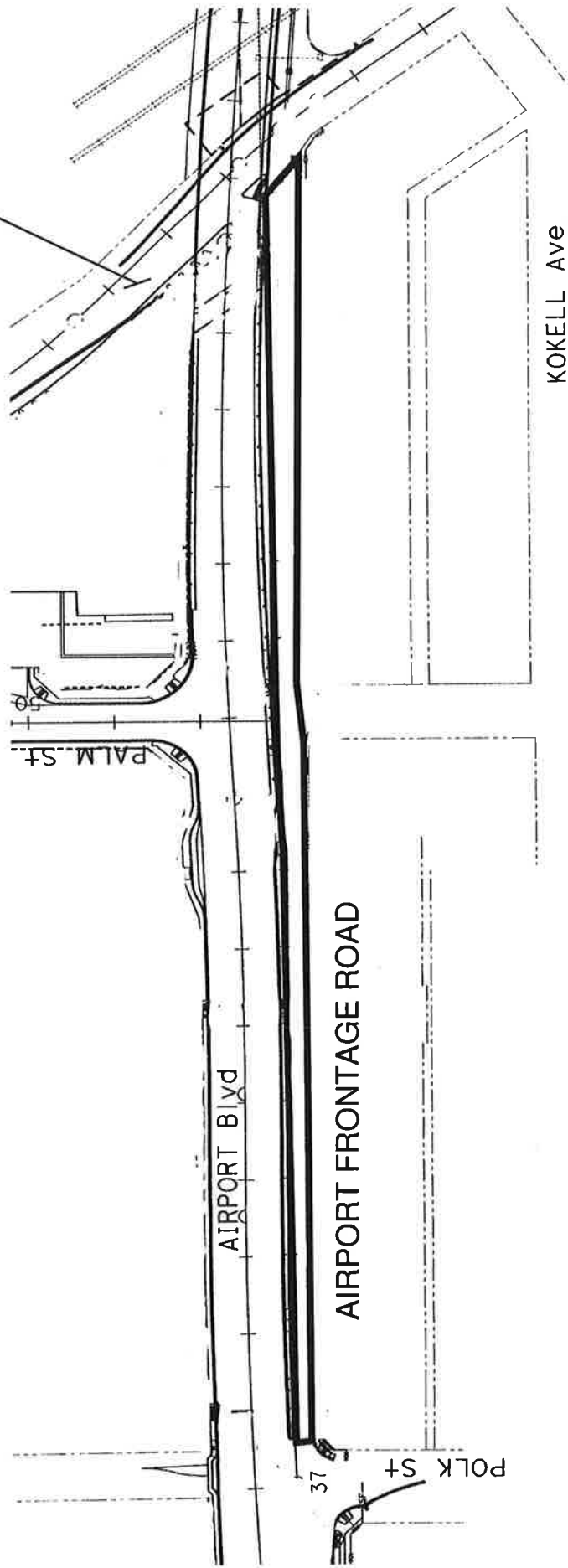

AND GRAPEFRUIT BOULEVARD

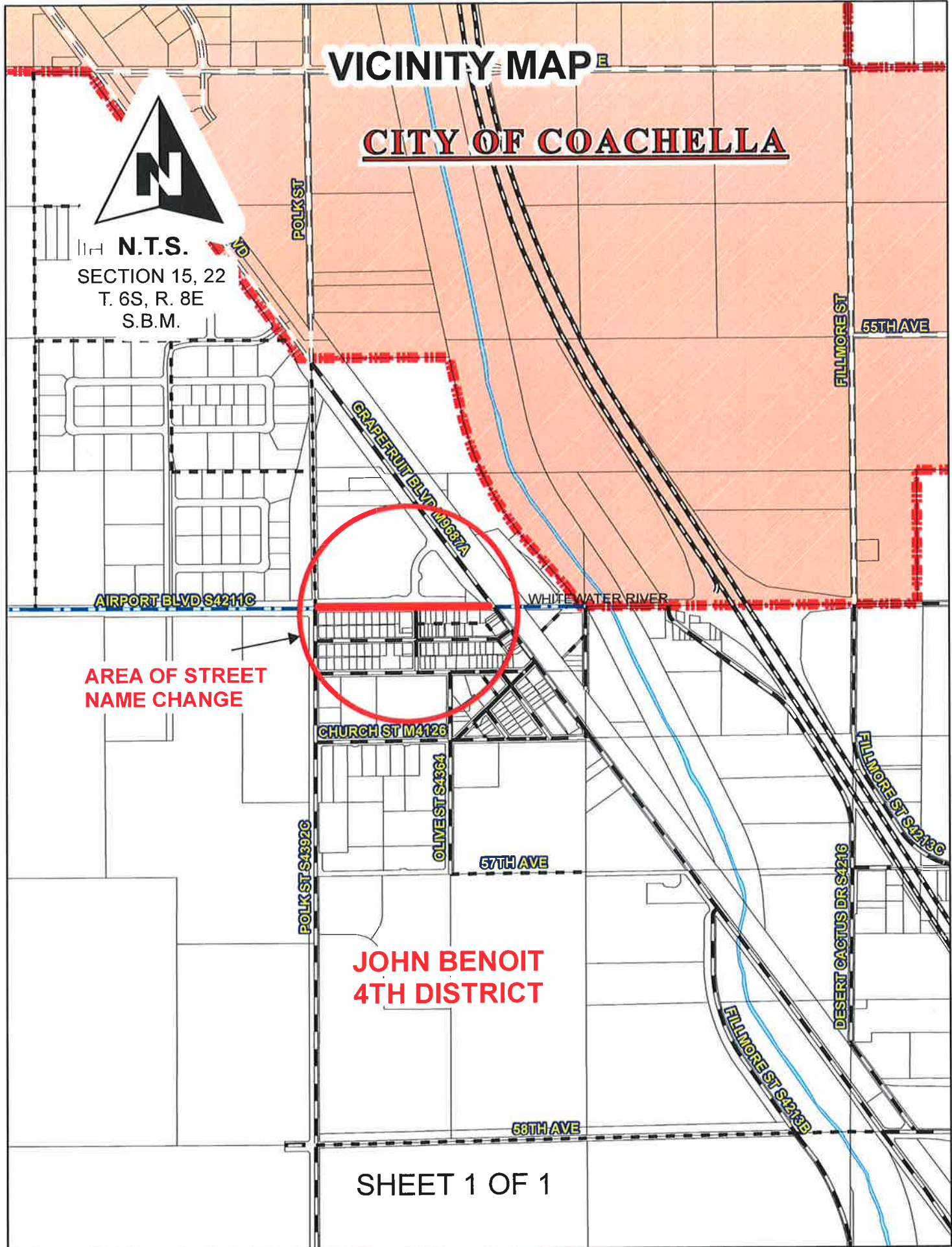
GRAPEFRUIT BOULEVARD
