BACKGROUND:

Summary (continued)

1. Green Coalition of San Jacinto Valley - \$500 the funding will be used for the Neighbors Night Out Program. The program is held in various neighborhoods in the San Jacinto Valley to allow residents to work together alongside public safety officers to curb neighborhood crime, gang and drug activity.
2. Anza Valley Chamber of Commerce - \$1,000 the allocated funding will be used for the Highway Retail Beautification project in which business members with the assistance of local service clubs will install new planter boxes and signage along Highway 371.
3. Assistance League of Temecula Valley - \$2,500 the funds will be utilized for Operation School Bell a program in the Southwest area that provides new school appropriate clothing for disadvantaged students grades K-12.
4. City of Murrieta- \$7,500 the funding will be used to purchase fitness equipment for the new fitness room at the Murrieta Senior Center.
5. Soroptimist International San Jacinto Hemet Valley – \$2,500 will be utilized for the Girls Empowerment Conference to teach girls about career choices and to promote the need for developing young women as leaders in our community.
6. Assistance League of Hemacinto - \$2,500 to be used for Operation School Bell in the Hemet / San Jacinto Valley to provide new school clothes for disadvantaged students grades K-8.
