The Matrix Model includes seven (7) key programs that complement each other and combine to produce an integrated outpatient treatment program, including recovery groups, relapse prevention groups, family education groups, social support groups, 12-step meetings and individual sessions. Each program contains a facilitator manual, handbooks, DVDs and CDs to reproduce client-related materials.
