- 1. San Jacinto Chamber of Commerce \$2,500 the funding will go to the chamber to support the programs and services the chamber offers to sustain and market the business community of the San Jacinto area.
- 2. Villa Chardonnay, Horses with Wings, Inc. \$5,000 the funding will be allocated to assist in purchasing a truck to deliver alfalfa which is the largest expense for the sanctuary.
- 3. Animal Rescue Friends of Idyllwild \$2,500 the funding will assist the rescue with microchipping and heartworm testing for local animals that have been abandoned in the Idyllwild area.
- 4. Young Men's Christian Association of Orange County \$4,000 the funding will assist with the Murrieta YMCA financial assistance program for low- income residents in the Murrieta area to participate in the health and wellness center.
- 5. Temecula VFW Post 4089 \$1,000 the funding will help to sponsor the SSGT Louis Cardin memorial monument fund.
