**BACKGROUND:**

**Summary**

1. The Agua Caliente Band of Cahuilla Indians will host the 3<sup>rd</sup> Annual Richard M. Milanovich Legacy Hike on May 6, 2016. This event will raise funds for the Richard M. Milanovich Fellowship which was created to give Native American students the opportunity to participate in a semester of political leadership in Washington DC. CID funds will be used to support the Richard M. Milanovich Fellowship.
2. The CSUSB Philanthropic Foundation will sponsor the 7<sup>th</sup> Annual Environmental and Sustainability Expo on May 6, 2016 at the California State University, San Bernardino Palm Desert Campus. This event will focus on renewable energy and environmental awareness. More than 300 students from the Coachella Valley will be attending. CID funds will be used toward the cost of transportation.

3. The Coachella Valley Volunteers in Medicine provides no-cost health care and dental services to the uninsured individuals residing in the Coachella Valley. CID funds will be used to support the volunteer program cost such as recruitment and training, software to manage volunteer information and a part-time volunteer coordinator.
4. The Desert Hot Springs Elks Lodge will host the 22<sup>nd</sup> Annual Golf Tournament on April 16, 2016. This fundraiser will provide low-income youth in Desert Hot Springs with scholarships for little league, soccer and football. CID funds will be used to support these scholarships.
5. The Regional Access Project Foundation is the fiscal agent for the Senior Inspiration Awards. The 24<sup>th</sup> Annual Senior Inspiration Awards luncheon was held on March 25, 2016. This event recognized and honored 11 honorees from each Coachella Valley city and the County of Riverside. CID funding will be used toward printing and marketing cost.
6. The RCRMC Foundation will host the annual Spring Garden Tour on May 7, 2016. This event raises funds to benefit the Child Abuse and Neglect Unit. CID funds will be used toward the cost of medical equipment in the RCCAT/CAN Unit.
7. The Rotary Club of Palm Desert Foundation will host the annual Education Hall of Fame Luncheon on March 29, 2016. This event raises college scholarship funds for local high school seniors in the Coachella Valley. The Palm Desert Rotary will award scholarships in the amount of \$1,000 to qualifying high school seniors to attend College of the Desert or California State University, San Bernardino Palm Desert. CID funds will be used for scholarships.
