RECOMMENDED MOTION (continued):

3. The Estate of Elizabeth Polk or anyone having possession or control of the vehicles is required to abate the public nuisance by removing them from the subject property, or lawfully enclosing them in a building, within ninety (90) days of the posting and mailing of the Board's Order.

4. If The Estate of Elizabeth Polk or anyone having possession or control of the abandoned, wrecked, dismantled, or inoperative vehicles and/or parts thereof does not properly abate the public nuisance within ninety (90) days of the posting and mailing of the Board's Order, a designated representative of the Code Enforcement Department, a towing contractor and/or Sheriff's Department representative may abate the public nuisance by removal and destruction pursuant to Riverside County Code No. 520 and applicable laws.

5. The reasonable costs of abatement, after notice and an opportunity for hearing shall be imposed as a lien on the subject real property which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinances 520 and 725.

6. County Counsel be directed to prepare the necessary Statement of Decision Affirming and Upholding the Hearing Officer's Decision that the abandoned, wrecked, dismantled, or inoperative vehicles and/or vehicle parts on the real property are declared to be in violation of Riverside County Ordinance No. 520 and a public nuisance and further, to prepare the Order for approval by the Board.

BACKGROUND:

1. As authorized by California Vehicle Code Sections 22660 and 22661 and California Government Code Section 25845, Riverside County Ordinance No. 520 prohibits the outside storage of abandoned, wrecked, dismantled or inoperative vehicles and vehicle parts on private property and deems the condition a public nuisance. Furthermore, Riverside County Ordinance No. 520 authorizes the removal and destruction of the vehicles constituting a public nuisance.

2. Initial inspection was made on the subject property by Code Enforcement Officer Jennifer Morris on June 16, 2015. The inspection revealed three (3) abandoned, wrecked, dismantled, or inoperative vehicles on the subject property in violation of Riverside County Ordinance No. 520.

3. There have been approximately four (4) follow up inspections, with the last inspection occurring on January 12, 2016. All three (3) vehicles listed on the vehicle inventory sheet remained on the property and in violation of Riverside County Ordinance No. 520.

4. The property owner is deceased. Pursuant to the request from occupant Debbie Polk, an administrative hearing was held on September 3, 2015, wherein, the Hearing Officer issued his decision and determined that all three (3) abandoned, wrecked, dismantled, or inoperative vehicles on the subject property constitute a public nuisance in violation of Riverside County Ordinance No. 520 and ordered all three (3) vehicles removed from the property within eleven (11) days, until September 14, 2015.

5. On or about September 24, 2015, a request for an appeal of the Administrative Hearing Order/Decision was received from occupant Debbie Polk, with a mailing date of September 21, 2015. Notice of the appeal hearing before the Board of Supervisors has been given as required by law.

1 I, Jennifer Morris, declare that the facts set forth below are personally known to me except to the
2 extent that certain information is based on information and belief which I believe to be true, and if called
3 as a witness, I could and would competently testify thereof under oath:

4 1. I am currently employed by the Riverside County Code Enforcement Department as a
5 Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting
6 property for violations and enforcement of the provisions of Riverside County Ordinances.

7 2. California Vehicle Code Sections 22660 and 22661 and Riverside County Ordinance
8 ("RCO") No. 520 provide for the abatement and removal as a public nuisance of abandoned, wrecked,
9 dismantled, or inoperative vehicles, or parts thereof from private or public property and the recovery of
10 administrative fees and removal costs.

11 3. On June 16, 2015, I conducted an inspection of the real property described as 23560
12 Marshall Street, Perris, Riverside County, California, and further described as Assessor's Parcel Number
13 325-181-001 (hereinafter described as "THE PROPERTY"). A true and correct copy of a Thomas
14 Brothers map page indicating the location of THE PROPERTY is attached hereto and incorporated
15 herein by reference as Exhibit "A."

1 4. A review of County records and documents disclosed that THE PROPERTY is owned by
2 Elizabeth Polk (hereinafter referred to as "OWNER") who is deceased. THE PROPERTY is occupied by
3 Debbie Polk (hereinafter referred to as "OCCUPANT"). A certified copy of the County Equalized
4 Assessment Roll for the 2015-2016 tax year and a copy of the report generated from the County
5 Geographic Information System ("GIS") is attached hereto and incorporated herein by reference as
6 Exhibit "B."

7 5. On June 16, 2015, pursuant to an inspection warrant MISC 2015-087, I conducted an
8 inspection of THE PROPERTY. I inventoried and photographed three (3) abandoned, wrecked,
9 dismantled, or inoperative vehicles.

10 6. The Vehicle Inventory dated June 18, 2015, identifying each abandoned, wrecked,
11 dismantled, or inoperative vehicle is attached hereto and incorporated herein by reference as Exhibit "C."

12 7. On June 25, 2015, Notice of Intent to Abate was mailed to OWNER and the identified
13 registered owners at the addresses listed with the California Department of Motor Vehicles ("DMV") by
14 certified mail return receipt requested and was posted on July 10, 2015. As part of the inventory, if the
15 vehicle identification number or license plate of a vehicle was ascertainable, the Code Enforcement
16 Department contacted the DMV for the name and address of the registered and legal owner of the
17 inoperative vehicle. Based upon information obtained from the DMV, I am informed and believe that the
18 last registered owners of the abandoned, wrecked, dismantled, or inoperative vehicles located on THE
19 PROPERTY (hereinafter cumulatively referred to as "ALL REGISTERED OWNERS") were identified and
20 noticed.

21 8. Photographs depicting the condition of THE PROPERTY are attached hereto and
22 incorporated herein by reference as Exhibit "D."

23 9. A true and correct copy of each Notice issued in this matter and other supporting
24 documentation are attached hereto and incorporated herein by reference as Exhibit "E."

25 10. There have been approximately four (4) follow up inspections on THE PROPERTY, the
26 last occurring on January 12, 2016. From the road right of way, I observed all three (3) vehicles listed on
27 the vehicle inventory sheet remained on THE PROPERTY and in violation of RCO No. 520.

28 ///

1 11. Based upon my experience, knowledge and observation, the abandoned, wrecked,
2 dismantled, or inoperative vehicles constitute a public nuisance in violation of the provisions set forth in
3 RCO No. 520 in that they are not lawfully enclosed in a building, are not stored or parked in connection
4 with the business of a licensed dismantler, licensed vehicle dealer, a junk dealer or other lawfully
5 conducted business or commercial enterprise.

6 12. Furthermore, a recent inspection showed THE PROPERTY remained in violation of RCO
7 No. 520.

8 13. A Notice of Pendency of Administrative Proceedings was recorded in the Office of the
9 County Recorder, County of Riverside, State of California, on October 27, 2015, as Instrument Number
10 2015-0471666. A true and correct copy of which is attached hereto and incorporated herein by reference
11 as Exhibit "F."

12 14. At the request of OCCUPANT, an Administrative Hearing was scheduled for September 3,
13 2015, Michael Orr presiding as the Hearing Officer.

14 15. Based on information and belief which I believe to be true, the Notice of Decision was
15 mailed to OWNER on September 9, 2015 and was posted on THE PROPERTY on September 11, 2015.
16 The Hearing Officer's decision was in favor of the County of Riverside. The Hearing Officer gave
17 OWNER eleven (11) days, until September 14, 2015, to remove all vehicles identified in the attached
18 Vehicle Inventory and located on THE PROPERTY. The decision stated that Riverside County Code
19 Enforcement shall have the authority to abate and remove all vehicles identified in the attached Vehicle
20 Inventory located on THE PROPERTY. A true and correct copy of the Notice of Decision, Proof of
21 Service, and Affidavit of Posting is attached hereto and incorporated by reference as Exhibit "G."

22 16. On September 24, 2015, Code Enforcement received a letter from OCCUPANT with a
23 mailing date of September 21, 2015, requesting an appeal of the Hearing Officer's Decision to the Board
24 of Supervisors. A true and correct copy of the letter is attached hereto and incorporated by reference as
25 Exhibit "H."

1 17. A Notice of Hearing on Appeal of Administrative Hearing Decision on the Abatement of
2 Vehicles and Vehicle Parts providing notice of the Board of Supervisors Hearing as required by RCO No.
3 520 was mailed to OWNER and OCCUPANT by first class mail and was posted on THE PROPERTY.
4 True and correct copies of the Notice, together with Proof of Service, and the Affidavit of Posting of
5 Notices are attached hereto and incorporated by reference as Exhibit "I."

6 18. I am informed and believe that the OWNER and/or OCCUPANT does not have legal
7 authority or permission to store the abandoned, wrecked, dismantled, or inoperative vehicles and vehicle
8 parts on THE PROPERTY.

9 19. The removal or lawful enclosure in a building of all abandoned, wrecked dismantled, or
10 vehicles and parts thereof as identified in the Vehicle Inventory is required to bring THE PROPERTY into
11 compliance with RCO No. 520.

12 20. Accordingly, the following findings and conclusions are recommended:

13 a) the Administrative Hearing Officer's Order / Decision be AFFIRMED and UPHELD;
14 b) the vehicles or parts thereof as set forth in the Vehicle Inventory, attached hereto
15 as Exhibit "C" be declared to be abandoned, wrecked, dismantled or inoperative and declared a public
16 nuisance in violation of RCO No. 520, as determined by the Administrative Hearing Officer;

17 c) the OWNER or OCCUPANT, or anyone having possession or control of the
18 abandoned, wrecked, dismantled or inoperative vehicles or vehicles parts be required to abate the public
19 nuisance by removing or lawfully enclosing in a building the vehicles as set forth in the Vehicle Inventory
20 within ninety (90) days of the posting or mailing of the Board of Supervisors' Order pursuant to RCO No.
21 520;

22 d) If the above described public nuisance is not abated in strict accordance with all
23 Riverside County Ordinances, including RCO No. 520, within ninety (90) days after posting and mailing
24 of the Board's Statement of Decision, a designated representative of the Riverside County Code
25 Enforcement Department, a towing contractor and/or Sherriff's Department representative may abate the
26 public nuisance by removal and destruction of the abandoned, wrecked, dismantled or inoperative
27 vehicles and parts thereof pursuant to RCO No. 520 and applicable law upon receipt of an owner's
28 consent or Court Order where necessary under applicable law;

1 e) that reasonable costs of abatement, after notice and opportunity for hearing, shall
2 be imposed as a lien on THE PROPERTY, which may be collected as a special assessment against THE
3 PROPERTY, pursuant to Government Code Section 25845 and RCO No. 725.

4 I declare under penalty of perjury under the laws of the State of California that the
5 foregoing is true and correct.

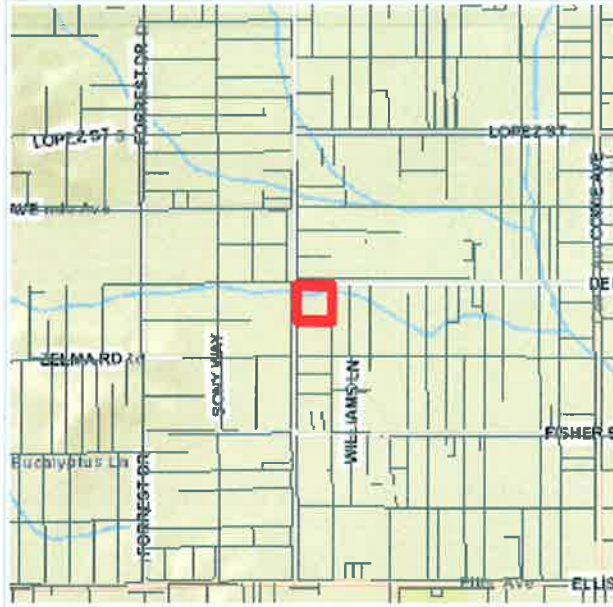
View Parcel Map
